# **COMPLIANCE MONITORING**

## **Holley Heyert** CHI2297

The Board discussed Dr. Heyert's second Monitoring Report which was the first report submitted by her new monitor, Dr. Dan Van Roon. Dr. Van Roon recommended that Dr. Heyert implement electronic record keeping. Dr. Jolly noted that electronic health records (EHR) are not required by Board regulations and can be costly. She added that there should be consistency with the type of note format used, such as SOP or SOAP. The Board agreed that improvement in note taking is the ultimate goal and that note format could be discussed at a future meeting. Dr. Heyert also submitted a Corrective Action Report.
