PUBLIC MEETING MINUTES

JUNE 3, 2021

A posted public meeting of the Massachusetts Board of Registration of Chiropractors (the Board) was held remotely by telephone or by videoconference as an alternate means of public access pursuant to an Executive Order issued by the Governor of Massachusetts dated March 12, 2020 suspending certain provisions of the open meeting law.

Dr. Shilts noted a quorum of members present and called the meeting to order at 10:02 a.m.

CHAIRMAN MESSAGE

Dr. Shilts reminded the Board about a chiropractor who passed away recently, and the family contacted the DPL for advice on what to do with the records. He disclosed that he found a chiropractor on behalf of the family to take possession of the records.

Dr. Shilts informed the Board that the State of Emergency is planned to be lifted in just over a week; however, healthcare settings, community housing, schools and public transportation are expected to continue the mask requirement.

Dr. Shilts said our "approval" of the agenda will change to "setting" the agenda which is more consistent with Robert's Rules.

Atty. Kilb gave a brief overview of The Commonwealth's Conflict of Interest and Open Meeting Laws. He also discussed when Board members should recuse themselves from Board discussions or votes.

Atty. Kilb said after the State of Emergency is over on June 15th, the Open Meeting Law will require our meetings to return in person at the DPL for August unless otherwise notified.

LEGAL COUNSEL REPORT

Atty. Kilb said that Governor Baker is planning to file Article 87 legislation, which is a reorganization bill that would transfer the chiropractic board and other health-related boards from the DPL to the Department of Public Health. He said if it does happen, the bill can only reorganize the executive branch - and the Board would still retain the statutory authority it has now.
