CHAIRMAN'S MESSAGE

The Board reviewed continuing education credits submitted by Dr. McManus for reinstatement of his chiropractic license. Dr. Shilts said he counted 95 credit hours.

The Board gave direction to staff to further review the submitted continuing education credits with the Board chair and to follow-up with Dr. McManus.

Dr. Jacobs and his legal counsel Ingrid Martin participated by telephone to discuss his request to reinstate his suspended chiropractic license.

Dr. Maddalo said that chiropractors with an NPI number can order COVID rapid tests. She will forward this information to Mr. Lawless.
