22 "This is a vote to approve and
23 consent to the city of Boston,
24 making a submission to the

1 Executive Office of Energy and
2 Environmental Affairs, and
3 petitioning the General Court of
4 the Commonwealth of Massachusetts
5 to permit the granting to or
6 taking by the city of Boston,
7 acting by and through its public
8 improvement commission of a
9 highway easement for said
10 reconfiguration of Joslin Place
11 and Joslin Park as depicted
12 approximately as highway easement
13 area on that certain plan," for
14 which we do not have a title,
15 "dated," for which we do not have
16 a date, "and prepared by VHB,
17 Inc., showing approximate
18 acreage, location and boundaries
19 and licensing in connection
20 therewith to the owner of One
21 Joslin Place and its air rights
22 tenant for up to 54 months for the
23 reconfiguration of Joslin Place
24 and Joslin Park and associated

1 site work and park improvements
2 and also involving areas within
3 Joslin Park supporting the
4 construction of its Future Cancer
5 Hospital and the reconfigured
6 Joslin Place and Joslin Park, all
7 of which is to be constructed by
8 the owner of One Joslin Place and
9 its air rights tenant."
