Ercoli Inc. d/b/a Via Alto (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, April 1, 2014, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Bailey's Report.

- 1. On Thursday, April 11, 2013, at approximately 7:17 p.m., Investigators Bailey and Doyle conducted an investigation of the business operation of Ercoli Inc. d/b/a Via Alto.
- 2. An underage operative, working with investigators, purchased an alcoholic beverage, a bottle of Bud Light beer for three dollars (\$3.00). The underage operative was not asked for identification.

## **CONCLUSION**

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age. The Commission, upon deliberation, took into consideration the extremely serious medical and financial circumstances of the licensee. Therefore, the Commission suspends the license for one (1) day of which one (1) day will be held in abeyance for a period of one (1) year, provided no further violations of Chapter 138 or Commission Regulations occur.
