- 1. **Vote/Discuss Draft Meeting Minutes.** On a **MOTION** by Rebecca Haney, 2nd by Lisa Berry, it was unanimous VOTE by ROLL CALL to table the February 17, 2021 draft meeting minutes to give Rebecca Haney time to offer a summary of the Nationwide Study (**EXHIBIT B**).
- Review Coastal A Zone BLENDED Findings_Lisa E_Anrew K 12-16-20_Working Draft_Joy D. Comments 12-18-2020 R. Haney 1-4-2021 J. Duperault 2-12-2021 G (EXHIBIT C). The group reviewed the first paragraph and had no objections with it. Next the group reviewed the Findings for Coastal A Zone portion. Other than some grammatical edits to #7, and clarifying 16 CRS coastal communities in #8, the group expressed no objections with all 8 sections as renumbered after assigning #5 to a paragraph.

The group next reviewed the Storm and Flood Damage within Coastal A Zones section. The group edited the title by adding "Presentations" before the word Storm. On the fourth line, after Brian Caufield, the group added "Jonathan Westcott and Dr. Shane Parson".

Then in #1, the group added "may be" after the term slab in the second line. With this edit, the group expressed no objections. With respect to #2, the group expressed no objection.

After lengthy discussions about the updated text in the first two paragraphs under #3, the group ran out of time. Concerns about the information conveys data about damage to structures outside Coastal A Zones.
