## DECISION

COHASSET SARRO, INC. DBA RED LION INN 71-85 SOUTH MAIN ST. COHASSET, MA 02025 LICENSE#: 023800008

Cohasset Sarro, Inc. dba Red Lion Inn (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, September 3, 2013, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Kelleher's Report.

The following documents are in evidence:

- 1. Investigator Kelleher's Compliance Check Field Report dated April 10, 2013; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

## **FACTS**

- 1. On Wednesday, April 10, 2013, at approximately 6:46 p.m., Investigators Carey and Kelleher conducted an investigation of the business operation of Cohasset Sarro, Inc. dba Red Lion Inn.
- 2. An underage operative working with investigators purchased an alcoholic beverage, a bottle of Budweiser Light beer, for five dollars and thirty cents (\$5.30). The underage operative was not asked for identification.

## **CONCLUSION**

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age. As the licensee has been in business for fifteen (15) years and has had no previous violations, the Commission issues a **WARNING.**
