ORDER

SAJJAN ENTERPRISES, LLC D/B/A COHASSET WINE AND SPIRITS 27-29 SOUTH MAIN STREET COHASSET, MA 02025 LICENSE#: 0238-00015

On July 20, 2016, the Alcoholic Beverages Control Commission ("Commission") dismissed Sajjan Enterprises, LLC's ("Sajjan") appeal of the Local Board's denial of its application to transfer its license without prejudice. In its Decision, the Commission held that "[w]ithout a renewed license, [Sajjan's] underlying appeal before the Commission is moot."

Sajjan appealed the Commission's decision to the Superior Court. <u>Sajjan Enterprises, LLC d/b/a</u> <u>Cohasset Wine and Spirits v. Alcoholic Beverages Control Comm'n</u>, 1684 CV 02564. On February 8, 2018, the Superior Court remanded the appeal to the Commission with a suggestion that the Commission further remand the matter to the Local Board "to address the renewal issue."

Consistent with the Superior Court's Memorandum and Decision of February 8, 2018, the Commission hereby remands this matter to the Local Board to address the issue of Sajjan's failure to appeal the denial of its 2016 renewal application that the Commission raised in its July 20, 2016, Decision.
