Key Issues Raised in Public Comments

- Draft 2030 Plan issued for public comment in Fall 2019
- Key issues raised
 - Urged more engagement and need for more input from Environmental Justice communities
 - Concerns with carbon emissions and climate change impacts from solid waste management
- Since then solid waste and materials management affected by COVID 19

Reopening Comment Period

- MassDEP will reopen comment period on Draft 2030 Plan
- Will run from June 26 through September 15
- Four public hearings via Zoom
 - All held in evening from 6-8
 - July 22, August 20, September 1, September 10

Key Questions for Comments

- Specific challenges face by populations disproportionately impacted by solid waste facilities? How could SWMP address these challenges?
- How can Environmental Justice (EJ) communities be better reflected in how waste is managed in Massachusetts?
- Specific policies or programs to address SW management concerns of EJ communities?
- What actions to pursue to reduce carbon emissions from SW management to help meet Global Warming Solutions Act goals?
- What are COVID 19 impacts on SW management? Specific initiatives problematic/beneficial to adjust to COVID 19 impacts?



What's Your New Normal? A Community Forum on Trash & Recycling June 16, 2020



Highlights

- Communities are not experiencing issues accessing PPE.
- Fifty percent of those polled have experienced higher trash and/or recycling costs since COVID.
- Two thirds of those polled have seen a trash tonnage increase of 5% or more.

Many drop-off programs suspended or altered collection of certain materials. Some are now reopening.

Many Swap Shops have been closed and have not yet reopened.

Suspension & Modification of Programs



Special events have been suspended – particularly household hazardous waste collections and paper shredding events.





Revising large events to focus on only one material at a time for a limited time (e.g. 4 hours on a weekday).



Adoption of new technology (e.g. online payments, online appointment scheduling) to continue their programs and promote safety.



The following reflects the survey completed by 48 stakeholders in May-June 2020





C&D Recycling Industry and Markets in a COVID-19 World


- Regional C&D activity impacted
 - Lowest point in April (20%-50% of norm)
 - Started to recover in May
 - Approaching pre-Pandemic levels in June
- Waste Bans remained in effect throughout
 - C&D handling facilities designated essential service
 - Maintained operations modified for safety (2 exceptions in metro-Boston area)
 - No disruptions experienced moving materials to end-markets
- Under 4-phase Reopening Plan
 - All C&D handling facilities continue operations in strict compliance with mandatory COVID-19 safety protocols

CY2019 MPS Status

Criterion #1: Process Separation Rate (PSR)

18 C&D Processors

11 Lg. C&D Transfer Stations



Request for Information (RFI) Letters

- Site audits to verify data have always been part of MPS implementation plan
- Collect relevant information more efficiently
 - Reduce time onsite consistent with COVID-19 safety protocols
- Collect monthly operational data for first 6 months of 2020
 - Better understand impact of COVID-19
 - Factor into compliance evaluations in 2021
- Include questions about CY2019 Annual Report Data
- Send out RFI letters before end of June
