## URGENT, ACTION NEEDED: Agencies with older model Motorola radios must ensure their radios are licensed for the new statewide system now

January 30, 2026

**Summary:** There are several models of Motorola radios currently in use on the statewide CoMIRS 700/800 system that are out of support (OOS). The CoMIRS Program Management Office has negotiated a program to reopen licensing for these radios for CoMIRS users. **This program closes soon and will not be reopened. Agencies with these radios must ensure that their radios have all of the licenses needed to operate on the new digital system.**

**Action Needed:** If your agency is listed below, records indicate your agency has at least one OOS radio. Please confirm that your agency has obtained licenses for these radios to work on the new system, including P25 Digital Trunking, P25 Link Layer Authentication, and Over the Air Programming. To determine compliance, radios can be read into the CoMIRS Radio Management (RM) tool. Your typical radio technician should be able to help read these radios into RM. The process does not take long but does require a technician to physically touch each radio.

Once read into RM, the CoMIRS team will work with Motorola to evaluate each radio. If upgrades are needed, our office will reach out to you to coordinate a chargeback to pay for any missing licenses.
