Background on 'Employment Program for Young Adults with Disabilities'

For the Commonwealth Corporation for an employment training program for unemployed young adults with disabilities; provided, that funds shall be awarded competitively by the Commonwealth Corporation to community-based organizations with recognized success in creating strong collaborations with employers to consider young adults with disabilities; and provided further, that a community-based organization that receives funding under this item shall provide extensive training, internship programming, and ongoing post-placement support for participants and employers

KEY ELEMENTS OF PROGRAM DESIGN

- Occupational skills training <u>directly related to demand</u> <u>occupations</u> identified by the employer partners
- Work experience (such as internships)
- Job development and placement in unsubsidized, paid positions
- Post-placement support
- Coaching and case management
- Support services and resources as needed to participate in training and transition to work

TARGET POPULATION

YOUNG ADULTS WITH DISABILITIES

As described by the following criteria:

- Unemployed or underemployed and.
- Have a diagnosed disability and,
- Between 18 and 35 years old and,
- Not enrolled in high school as of program start (may or may not have previously earned a high school diploma or HiSET/GED)






PY 24 GENDER BREAKDOWN
