

Discussion Question 1 – Closing the Gap Between Available Jobs and Workers

How do we close the gap between available jobs and available workers (i.e., apprentice electricians)? Currently, there appears to be a mismatch between residential customer electrician needs and trained, skilled workforce availability.



Discussion Question 2 – Timing of the Transition

How do we want to address 'timing of the transition' in the report? Should we align with Massachusetts' Clean Energy and Climate Plan for 2050 roadmap?



Discussion Question 3 – Federal Administration Impact

How do we want to include references to federal administration and policy landscape impact on workforce transition?
