## MEMORANDUM

RE: Commonwealth Appropriation for Fiscal Year 2020

DATE: May 9, 2019

Required Fiscal Year 2020 Appropriation: **\$2,841,524,605**

This Commission is hereby furnishing you with the Commonwealth pension appropriation for FY20 which commences July 1, 2019. This amount reflects the triennial funding schedule filed on January 13, 2017 with payments increasing 8.94% each year until FY36. The funding schedule was determined based on the results of the January 1, 2016 Commonwealth actuarial valuation.

Chapter 5 of the Acts of 2017 provides for several items included in the development of the Commonwealth funding schedule to be shown separately. These items include the administrative expenses for PERAC, the employer contribution to the optional retirement plan (ORP) under Section 40 of Chapter 15A, and the reimbursements to local systems for cost of living adjustments made from 1981 through 1996. These amounts are estimated for FY20 based on information currently available.

The FY20 allocation is as follows:

Massachusetts Teachers' Retirement System	1,557,500,000
Boston Teachers	157,040,605
Administrative Expenses for PERAC	10,384,000
Employer contribution to ORP	14,600,000
Local COLA reimbursement	18,000,000
Total	\$2,841,524,605
