*Rates are computed on an hourly basis anywhere within the Commonwealth of Massachusetts.

Rate A -- Applies to services performed Monday through Friday between the hours of 8:00AM and 5:00 PM, excluding Federal and State Holidays.

Rate B -- Applies to services performed Monday through Friday between the hours of 5:00PM and 8:00AM, excluding Federal and State Holidays.

Rate C – Applies to services performed on Saturdays and Sundays and on Federal and State Holidays.

TRAVEL TIME An additional charge shall be assessed for each vehicle and driver, helper(s), and supervisor to cover their travel time. Travel time is calculated as follows:

A – Up to and including 10 miles from our original point of origin to final destination and back to our starting point. ----- Add ½ Hour

B – Each additional 10 miles or fraction thereof-----Add ½ Hour

Note: Mileage determined by Mapquest.

The above rates are for the moving of household goods and furniture only and do not include the packing and storage thereof. Separate charges will be assessed for both packing and storage of household goods.

The carrier cannot quote a firm price on a move from a residence or establishment to another if a public way has to be used by a vehicle.

MINIMUM CHARGE – A minimum charge of **TWO HOURS** shall apply on each shipment, in addition to the appropriate TRAVEL TIME.

CANCELLATION FEE – If a scheduled job is cancelled on the day of said job the **MINIMUM CHARGE** shall be applied. If a scheduled job is cancelled 24 hours before scheduled time a **STANDBY FEE OF \$250.00** shall be assessed.
