Communities Inmates Released to in 2016



The population covered in this report, termed 'release to the community population', includes any criminally sentenced inmate released to the community from a Massachusetts Department of Correction (MA DOC) facility as well as DOC inmates released from other correctional facilities (jurisdiction). Under this definition, DOC inmates released from Massachusetts' Houses of Correction, other states' correctional facilities and the Federal Bureau of Prisons during 2016 are included in the population. The population described in this report includes criminally sentenced inmates released via expiration of sentence, parole to the street, releases from parole detainers, court releases and payments/expirations of fine.

Inmates under the jurisdiction of the Massachusetts Department of Correction (MA DOC) are released to many different communities throughout the state and in some cases are released to communities outside of Massachusetts. This brief is a statistical look at the communities to which criminally sentenced inmates are being released¹. For the purposes of this report, communities may refer to counties, cities, towns or municipalities both in and outside of Massachusetts.

During calendar year 2016, there were 2,328 releases to the community, which was a decrease of 252 releases (10%) from 2015. Males in particular saw an 11% decrease from the previous year in number of releases (n = 223) driven by a decrease in paroles to the community. Female releases also experienced a 5% decrease from 552 in 2015 to 523 in 2016 (n = 29), largely as a result of a decrease in females being released via expiration of sentence.

¹ Information regarding release address is self-reported by inmates prior to their release. It is likely that some release addresses reflect temporary and residential treatment locales, and not necessarily long term residences in the community. If a release address is not reported by the inmate, their last known address was used.



- The majority (52%) of the releases during 2016 had a reported release address in one of the top ten cities/towns listed in Table 1.
- Mirroring 2015, the release address with the highest number of releases reported was to the various communities in the city of Boston (19%) followed by Springfield (6%) and Worcester (5%).
- Despite change in rankings, the top 10 cities/towns remained the same from the previous year. It is important to note that Norfolk is in the top 10 due to the Transitional Treatment Program (TTP) within Pondville Correctional Center where numerous male inmates are housed temporarily upon being granted parole.

- Boston was the top city reported by both male (22%) and female (10%) inmates as their release address. The second most commonly reported city for males was Springfield (7%), followed by Worcester (6%) and Norfolk (5%).
- Similar to 2015, a majority of the male releases (57%) reported a release address in one of the top ten cities/towns.
- Females differed from the males where the second most commonly reported release address was Lynn (8%), followed by Lowell (3%) and Lawrence (3%).
- In contrast, the majority of females (58%) reported a Massachusetts release address outside one of the top ten cities/towns, while (38%) reported a release address in the top ten.
- Due to the higher volume of male inmates being paroled to the TTP, Norfolk for the second year in a row is listed in the top 10 release cities for males.
- Female releases by community are also somewhat skewed, due to the fact that not all counties house females.³

³ Not all Massachusetts counties house their female inmates. Massachusetts General Law dictates that females may be committed directly by the courts to the MA DOC for a House of Correction sentence. The counties of Barnstable, Berkshire, Bristol, Franklin, Hampden, and Suffolk house females in their county correctional facilities. Hampden County has increased their capacity to house county sentenced females for other western Massachusetts regions (including Worcester).

Twenty-one percent of the total population reported a release address located in Suffolk County, the highest of all Massachusetts Counties. Essex County had the second highest percentage of releases (14%) followed by Middlesex County with 11%. When looking at the concentration (the rate per 100,000 residents) of releases to the community, Suffolk County had the greatest concentration at 63 followed by Essex and Hampden Counties, each with 42. Although 11% of releases reported an address in Middlesex County (third highest), the significantly higher density of residents compared to other Counties made it so that it had the third lowest concentration of releases with 17.



- The greatest percentage of females were released to Essex County (24%), followed by Middlesex County (17%) and Plymouth and Suffolk Counties (11% each).
- Though the list of top releases addresses by Massachusetts County remained almost identical with the top Counties reported in 2015 for females, there was some variation for the proportion of releases to each County. The top four release Counties accounted for 64% of releases to the community in 2016, whereas they accounted for 69% of releases in 2015.
- No female releases reported a release address in Dukes or Nantucket Counties in 2016.

- The greatest percentage of males were released to Suffolk County (24%), followed by Essex County (11%) and Hampden County (10%).
- The top Massachusetts County reported for male releases mirrors the top reported for those released to the community in 2015 (Suffolk County). Worcester County, the fifth highest in 2016, was the third highest in the previous year due a nearly 30% decrease in releases.
- No male releases reported a release address in Dukes County in 2016.

Of the 2,328 inmates released to the community, 131 reported a release address outside of Massachusetts. Sixty percent of the inmates reporting a release address outside of Massachusetts, reported releasing to a New England state (n = 61) or New York (n = 18) which accounted for the majority of releases outside of Massachusetts for 2016. The proportion of inmates being released to a New England state or New York decreased from 64% to 60% when compared to the previous release year.
