

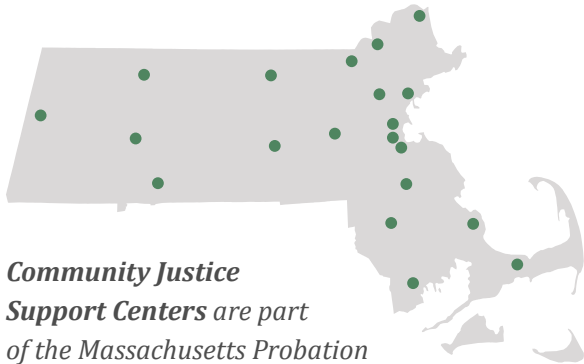


The Community Corrections Centers are now the Community Justice Support Centers

In Massachusetts, Community Justice Support Centers (formerly the Community Corrections Centers) offer rehabilitative services and support – with the goal of reduce recidivism – to individuals who have criminal justice involvement. These Centers, located in 18 communities across the state, provide participants with an opportunity to learn tools and techniques that will help them improve their lives and integrate into the community.

Services include:

- Cognitive Behavioral Treatment to address decision making and substance use disorders
- Education for GED/HiSET and college preparation, plus life skills such as financial literacy and computer and technology basics
- Employment support and career counseling to develop resumes, training, and resources to pursue a career



Community Justice Support Centers are part of the Massachusetts Probation Service mission to keep communities safe. Support Centers provide services and support to people in the community instead of jail or prison.
