Physical and Mental Health	<ul style="list-style-type: none"> • Service providers on site or easily accessible • Wrap around services in isolated location should be available • Partner with local community health centers to provide services (Harvard Street, etc.) • Community clinic and gym – possible available to neighbors too • Counseling, mentoring & peer support • Gym / pool/ exercise area/ fitness center / jogging path • Link public health & park recreational center that mirrors the club house • Connection to Harvard Street NHC • Should include MH on campus for everyday living not just psychiatric services (trauma, depression, wellness) for community • Get input from patients • Safety considerations • User-Friendly • Connected w/ natural environment • Can residents have pets?
Housing Stability	<ul style="list-style-type: none"> • Economies of scale with larger # of beds/ units • Address employment/training/ education • Long-term but not permanent for any resident, w/ transitional services to move to permanent housing • Connect to Mayor's affordable housing • Mixed use, community feel • Access to fresh groceries • More housing (100 as min.) • Large dorm → individual studio • Senior housing -- only affordable, low income • Job training – trades and crafts (rehab furniture, woodworking, steel work → sale cost is at such space

Open Space & Connectivity	<ul style="list-style-type: none"> • Flow between larger community & campus • No “us & them” • Welcome center, nonprofit offices • Landscaping to integrate with park, including pathways • Access/ conx to Forest Hills Cemetery • More permeable edges to campus • Dog Park • Community Garden, Meditation garden • Permanent Art • Performance Spaces • Create physical connective w/ F.P. connecting with transportation, Hubway station • Support park-related programming, urban farming, more greenspace • Nature as a Healing Force • Green/ Open Space with small sections named after surrounding neighborhoods • More green space or FP land increased • Recreational activity, community hub • Day care • Non-car access (bike paths), sidewalks • Slow streets, connections w/ Morton St • Units that have their own entrances to outside

Groups' Shared Visions for the Future of Shattuck

Group 1:

- A space integrated both with park and surrounding community, physically and also in services offered. (ex recovery services, child care, community clinics, etc.)
- Maintain focus on supporting homeless citizens and those at risk in danger of homelessness. For those at risk/in danger need ability to access services before they become homeless. Use model that builds on strengths, not focus on deficits.
- Mutually beneficial site/program

Group 2:

- Synergistic vision of leaning towards more open/green space
- Synergistic vision that leans towards built environment (housing, professional services)

Group 3:

- The campus can support a broad mix of public health and recovery and permanent supportive housing needs that are integrated into the original vision for the park as a whole. Environmental and design features should reflect the harmonious uses of the natural landscape, restoring connectivity into the park and integrated into the community. The Shattuck campus should be a model for the best emerging practices using nature as a healing force.
- Question about the long-term fate of shelters and methadone clinic and how these services could be offered in a more dignified and recovery-oriented or restorative manner.

Group 4:

- Mindful relationships and collaboration w/ Independent Living Facility on Morton Street & Forest Hills Cemetery.
