**The Office of Access and Opportunity – Compliance** presents "Compliance Corner." Look out for helpful hints & information about required compliance reporting in DCAMM's Contractor Management System (DCMS) and the Commonwealth's Affirmative Marketing Program.



General Contractors (GC) can pull a report in LCPTracker that gives a snapshot of the overall certified payroll (CPR) submissions on their DCAMM awarded construction project(s)? The '**CPR Status Report**' under the 'Special Reports' tab can be accessed with your Prime Approver login and shows contractors that have submitted CPRs, rejected or pending CPRs, contractors whose last CPR submitted is not marked final and contractors with no CPR submissions at all.

This is an incredibly useful tool to help GCs ensure all CPR reporting requirements are being met on their DCAMM awarded construction project and a way to stay on top of subcontractors that are delinquent with reporting. As a reminder, all contractors required to submit certified payrolls must do so in LCPTracker. CPR submissions are due EVERY WEEK.
