CRG Fresh LLC d/b/a Adelita ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, September 16, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Quinn & Doyle's Minimum Purchase Age Compliance Check Field Report.

FINDINGS OF FACT

- 1. On Wednesday, May 28, 2025, at approximately 5:45 p.m., Investigators Doyle & Quinn ("Investigators") conducted a compliance check at CRG Fresh LLC d/b/a Adelita.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one bottle of Modela beer, for six dollars and forty-two cents (\$6.42). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2017.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.
