**DECISION**

**FIORELLAMORE LLC D/B/A FIORELLA'S CONCORD**  
**24 WALDEN STREET**  
**CONCORD, MA 01742**

Fiorellamore LLC d/b/a Fiorella's Concord ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, September 9, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Quinn & Doyle's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Doyle & Quinn's Minimum Purchase Age Compliance Check Field Report, 5/28/2025;
2. ABCC Application Summary Review, Transfer of License Approved, 8/22/2017;
3. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

**FINDINGS OF FACT**

1. On Wednesday, May 28, 2025, at approximately 4:59 p.m., Investigators Doyle & Quinn ("Investigators") conducted a compliance check at Fiorellamore LLC d/b/a Fiorella's Concord.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one bottle of Miller Lite beer for six dollars and forty-two cents (\$6.42). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2017.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.
