DECISION

PAPA RAZZI TRATTORIA OF CONCORD D/B/A PAPA RAZZI 768 ELM STREET CONCORD, MA 01742 LICENSE#: 024400003 VIOLATION DATE: 06/06/2016 HEARING DATE: 12/06/2016

Papa Razzi Trattoria of Concord d/b/a Papa Razzi (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, December 6, 2016, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Doyle's Report.

The following documents are in evidence:

- 1. Investigator Doyle's Compliance Check Field Report dated June 6, 2016;
- 2. Licensee's Stipulation of Facts;
- A. Licensee's Bartender Training Manual;
- B. Licensee's External Audit Report; and
- C. Licensee's Counseling Report regarding Violation.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

1. On Thursday, June 6, 2016, at approximately 7:05 p.m., Investigators Doyle and Bailey ("Investigators") investigated the business operation of Papa Razzi Trattoria of Concord d/b/a Papa Razzi.

2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a bottle of Budweiser Light beer for five dollars and thirty-five cents (\$5.35). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
