Re: Massachusetts Tariff #5026

Gentlemen:

The management of Conlon Moving and Storage, Inc. (MA Certificate #5026) has decided to file to amend part of our current rates as a Common Carrier – Transportation of Household Goods between points in Massachusetts. This includes, 1) Time Basis Transportation Rates, 2) Item 100 (Containers) and, 3) Cartage Rates (Weight Basis – Warehouse Pickup and Delivery).

We submit that our filing for this tariff increase is reasonable and justified for the following reasons:


1. All operating costs associated with the moving industry have increased significantly. This would include, but is not limited to, vehicle maintenance, fuel and primarily insurances to operate as required.
2. Minimum wage for labor continues to climb, along with increasing all other labor costs.
3. Employee related costs including health insurance and benefits have increased significantly.
4. Cost of materials have increased significantly, both to produce and dispose of.

In anticipation of your approval for this rate increase, I would suggest an effective date of May 1, 2020.

A copy of our Certificate of Liability Insurance is enclosed as required.

TIME BASIS TRANSPORTATION RATES

Transportation rates covering movements of household goods and related articles as described in Rule 1, crated or uncrated or in containers, on an hourly basis up to and including 50 miles from point(s) of origin to point(s) of destination.

Regular Time Rates

Regular time rates apply when service is performed on weekdays Monday through Friday between the hours of 8:00 A.M. and 5:00 P.M.

Overtime Rates

Overtime rates apply when service is requested by the shipper to be performed on weekdays (Monday through Friday) between the hours of 5:00 P.M. and 8:00 A.M. and all day Saturday.

Sunday / Holiday Rates

Holiday rates apply when the service is requested by the shipper to be performed on legal holidays as set forth in Rule 16 or at any time on Sunday. (THESE RATES ARE DOUBLE THE REGULAR TIME RATES.)
