CONSOLIDATION AND CASE-MANAGEMENT ORDER

The purpose of this order is to commence a streamlined and cohesive effort to adjudicate approximately one hundred substantively related appeals.

The appeals were brought by members of the Massachusetts Teachers' Retirement System (MTRS) who wish to be enrolled in the benefits program known as Retirement Plus. See G.L. c. 32, § 5(4). Today, all or nearly all new MTRS members participate in Retirement Plus automatically. *Id.*

Between 2001 and 2022, each member who transferred into MTRS from another public retirement system received a 180-day opportunity to enroll in Retirement Plus. See Acts 2000, c. 114, § 2; 807 C.M.R. §§ 13.02, 13.04. Many teachers inadvertently failed to take advantage of their 180-day windows. As a result, the Legislature granted such "transfer" teachers a new opportunity to join Retirement Plus during the first half of 2023. See Acts 2022, c. 134, § 3.

In early 2025, MTRS made efforts to identify members who could have joined Retirement Plus during the 2023 enrollment window but failed to do so. MTRS furnished those members with decisions confirming their nonparticipation in Retirement Plus. The decisions described themselves as appealable to DALA. These appeals followed.

With the foregoing background in mind, it is hereby ORDERED as follows:

- 1. The appeals listed in Appendix A (consolidated appeals) are hereby consolidated for prehearing purposes.
- 2. Future submissions in any of the consolidated appeals shall be captioned with the case name and docket number appearing at the top of this order. The submissions shall note prominently whether they relate to all of the consolidated appeals or only to specific appeals, identified by docket number.
- 3. DALA will maintain submissions relating to all of the consolidated appeals in case file number CR-25-0244. To ensure that the histories of the individual appeals remain clear, each individual case file will include a notice stating that additional relevant papers appear in case file number CR-25-0244. Submissions relating only to specific individual appeals will be placed in the pertinent individual case files.
- 4. Submissions in any of the consolidated appeals shall be filed by email to dalapleadings@mass.gov. Individual petitioners making any submissions shall copy MTRS's counsel at james.o'leary@trb.state.ma.us (or at the updated address of any successor attorney). Submissions by MTRS applicable to all of the consolidated appeals shall be provided to all of the petitioners using the BCC (blind carbon copy) email function. Upon request, the docket clerk will provide MTRS with a list of all of the petitioners' email addresses as appearing in their notices of appeal.
- 5. Copies of this order will be provided to attorneys at the Massachusetts Teachers' Association and the American Federation of Teachers. Those organizations are asked to consider whether it would be permissible and appropriate for their attorneys to appear in these

proceedings on behalf of any petitioners. Any notices of appearance of counsel may be formatted informally but shall be filed as soon as practicable.

- 6. MTRS shall confer to the extent practicable with any attorneys appointed pursuant to paragraph 5. Within 60 days, MTRS shall propose any appropriate additions to or subtractions from Appendix A. By the same deadline, MTRS shall propose a schedule for the briefing of one or more motions to dismiss based on failure to state a claim (or other grounds). Without prejudice to subsequent good faith modifications, the proposal shall identify the specific appeals that MTRS expects each of the motions to dismiss to address. Further proceedings relating to any appeals not dismissed as a result of motions filed under this paragraph will be scheduled at a later date.
- The MTRS decisions that prompted these appeals told the petitioners unprompted that their entitlements remained unchanged. It is not necessarily clear whether communications of that type result in any practical consequences. By extension, it is not necessarily clear whether the MTRS decisions were appealable under the governing statute, G.L. c. 32, § 16(4). See Bretschneider v. Public Emp. Ret. Admin. Comm'n, No. CR-09-701 (Div. Admin. Law App. Nov. 13, 2009). See also Board of Health of Sturbridge v. Board of Health of Southbridge, 461 Mass. 548, 557 (2012). On the other hand, through their appeals, the petitioners have asked MTRS in substance to allow them to join Retirement Plus; and MTRS has not acted on those requests. These failures to act probably are appealable. See § 16(4); Lutes v. Clinton Ret. Bd., No. CR-07-1100, 2012 WL 13406332, at *2 (Contributory Ret. App. Bd. Nov. 16, 2012). It would make little practical sense to require each petitioner to file a new notice of appeal. If necessary, the consolidated appeals are instead likely to be construed as anticipating and extending to MTRS's appealable failures to act. Cf. Lutes, 2012 WL 13406332, at *2; McLeod

v. Malden Ret. Syst., No. CR-22-625, 2023 WL 9190008, at *1 n.2 (Div. Admin. Law App. Dec.

15, 2023).

8. The procedures established in this order are intended to facilitate the speedy and

fair disposition of the consolidated appeals, consistent with the various applicable laws. See G.L.

c. 7, § 4H; G.L. c. 30A; 801 C.M.R. § 1.01. The parties are instructed to state any objections

promptly if they believe that the procedures being employed here violate any of their statutory or

constitutional rights.
