CY2022 C&D Wood Market Disruption

- PRE-Greenleaf, Plainfield, CT (Biomass Boiler)
 - Major outlet for "A-wood" produced in MA
 - Turbine failure caused unscheduled shutdown (5/27/2022)
 - Repaired turbine installed and start-up underway
 - Date to resume full operation is TBD
- Impact on C&D Program
 - Affected 5 C&D Handling facilities
 - MassDEP issued temporary waste ban waivers
 - Allowed disposal of limited quantities of wood
 - Required maximum use of existing markets and continual search for new markets

2022 C&D MPS Status

18 C&D Processors

- All but 2 facilities are fully MPS compliant
- Remaining 2 facilities installed new process lines
 - Optimizing operations

11 C&D Transfer Stations

- All facilities are fully MPS compliant
- One facility changed permit classification from processor to transfer station in May-2022.
- Track MPS compliance through ongoing facility compliance inspections and annual reporting requirements
- CY2022 annual report data due 2/15/2023
 - Submit to MassDEP using new Compliance Activity System (CAS) app
