1. The DMH Area and site are typically defined as the last known address of an individual seeking continuing care services. The list or the cities/towns associated with each DMH Area and site can be found on the DMH website at www.mass.gov/dmh. In the middle column of page reached click on the DMH Offices link.
2. The Contact for Admission are individuals that should be contacted for information concerning paperwork receipt/completeness of a CC application, referral processes, checking on Area or Site Tie, and f/o to an application status until transfer/resolution of the referral
3. All addresses should clearly note: **“Attention: DMH Inpatient Continuing Care Referral”** to ensure proper and timely handling.
4. The AMD contacts are the individuals you should contact for discussion of the clinical information of individuals referred for CC, concerns about the status of a referral (accepted/denied/pending), wait for transfer, and/or concerns with issues managed by the Contact for Admissions.
