Course Approval Request:

LSPA: <u>Exposure Point Concentrations and You: Calculating 95% UCLs and Employing</u> <u>ProUCL to Compute Them for Use as EPCs</u> (8 Technical credits, date and location to be determined) **Recommend Approval.**

Mr. Siddique noted that the course, *Exposure Point Concentrations and You: Calculating 95% UCLs and Employing ProUCL to Compute Them for Use as EPCs*, is similar to one offered by Environmental Professionals of Connecticut, ("EPOC"). Ms. Williamson commented that the EPOC offering was an eight hour course with a component that pertained to Connecticut regulations. In that instance, she commented, the Board only approved the course for six credits. She added that there is some overlap between the LSPA course and EPOC's. She said that the Committee could approve the LSPA course with the designation "Course No. 1518A." She indicated that alternatively, the LSPA course could qualify as a new course because it contains new material. The Committee voted to recommend approval of the course for eight credits. Ms. Williamson concluded by stating that *Exposure Point Concentrations and You: Calculating 95% UCLs and Employing ProUCL to Compute Them for Use as EPCs*, will be listed as Course No. 1518A once the LSPA provides time, date, and location.
