Ms. Read asked for Board Member volunteers to attend adjudicatory hearings in disciplinary cases. She also discussed the law on service animals and emotional support animals.

# 4. Proposal for Extended Time on Written Exam for Applicants Using English Translation Dictionaries

The members present discussed a request for extra time on the licensing exam made by an applicant from out of country who uses a translation dictionary but failed the exam due to lack of enough time to understand the questions. The members discussed accommodating such requests while preventing abuse. The staff will work closely with the exam vendor, Pearson Vue, on a

case by case basis to allow such applicants to apply for an accommodation, show documentation of an IEP or English as a second language before scheduling extra time.

Ms. Talbot made a MOTION that 50% additional time on the written exam may be allowed for non-English speaking applicants on a case by case basis by the staff working with Pearson Vue. Ms. Pearson seconded the Motion. The Motion Passed 8-0.

A MOTION was made by **Ms. Pearson**, second by **Ms. Talbot** to adjourn for lunch and reconvene as the Salon Pathways Subcommittee. The Motion passed unanimously.
