- All programs funded by MOVA will have services and staffing reduced on July 1, 2022 without a critical, lifeline investment from the state
- The need for services, both in-person and remote, has increased exponentially as a result of the COVID-19 pandemic. Victims need consistent support now more than ever.
- MOVA funded programs are serving more victims than ever before in our agency's history, as illustrated by our FY21 data collection.
