

New Legislators Event Held at the Adams Courthouse

The Supreme Judicial Court (SJC) and Trial Court hosted new legislators in the main courtroom of the John Adams Courthouse, where they heard welcoming remarks by SJC Chief Justice Ralph Gants, Trial Court Chief Justice Paula Carey, Court Administrator Harry Spence, Senate President Stan Rosenberg, and Speaker DeLeo.

The bi-annual event introduces new legislators to the court system and court leaders, and includes a behind-the-scenes tour of the SJC chambers and consultation room. Speaker DeLeo and Senate President Rosenberg offered their insights on working and collaborating with the Judiciary.

"This is not your grandfather's Trial Court," said Speaker DeLeo, referring to the court system's innovative approaches to achieving justice, such as evidence-based specialty courts.

New England Public Policy Center Reports on CORI Reform at the Adams Courthouse

Policymakers met earlier this month at the Adams Courthouse to discuss why changes to the CORI laws aren't resulting in exoffenders ability to find jobs as expected. Changes to the CORI law, made in 2010 and 2012, "banned the box" on job applications requiring job seekers to disclose their criminal backgrounds, and took five years off wait times to seal criminal records from background checks.

Researchers from the Policy Center speculated that the 2.6% drop in the employment rate for Massachusetts residents with criminal records since the changes were enacted could be the result of exoffenders' belief that the revised CORI laws may improve their job prospects, causing them to seek better paying jobs than before. They also suggested that employers may also now use other ways to screen for ex-offenders, such as raising educational and/or experience requirements. Presenters and panelists alike called for more research to help people build "positive records" to enable them to contribute to the state's economy.
