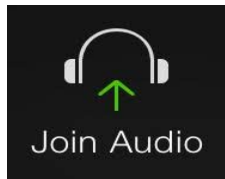


## WHEN JOINING US ON ZOOM:

**If you have an EMERGENCY:**

1. Visit our Virtual Court Service Center Monday – Friday; or
2. Visit one of the CSC locations on Tuesday and Thursday ONLY; or
3. Contact the Clerk or Registry nearest you to be connected to us

**Types of cases we CAN assist with:**

- ✓ Family Matters (Divorce, custody, child support, parenting time)
- ✓ Guardianships of Minors or Adults
- ✓ Name Changes or Corrections of Vital Records
- ✓ Voluntary Administrations
- ✓ Landlord/Tenant Matters
- ✓ Abuse Prevention/Restraining Orders/Harassment Orders
- ✓ Civil Commitments/Section 35
- ✓ Small Claims

**Cases we DO NOT assist with:**

- ✗ Formal/Informal Probates of Estate
- ✗ Adoptions
- ✗ Appeals
- ✗ Immigration
- ✗ Joint Petitions for Divorce
- ✗ Joint Modifications
- ✗ Most matters in Juvenile Court

Court Service Centers CAN provide:

- One-on-one help filling out court forms
- Information about court rules, procedures, and practices
- Court documents and written instructions
- Access to interpreter services
- Contact information for community resources, legal assistance programs, and social service agencies

Court Service Centers CANNOT provide:

- Legal advice
- Represent you in court
- Assist you if you have a lawyer
