At its meeting on April 13, 2009, the Board of Registration in Pharmacy (Board) reviewed your application for Pharmacy Technician Registration in Massachusetts along with related documentation accompanying your application. After careful consideration of the information before it, the Board voted to preliminarily DENY your application for registration.

The Board's preliminary denial is based on the documents contained in your application file:

Any such request must be received by the Board **within 21 days of the date of this letter of preliminary application denial** to the Board of Registration in

**NOTICE OF OPPORTUNITY FOR HEARING ON APPLICATION DENIAL**

You are hereby advised that you may request an opportunity for a hearing on the Board's preliminary denial of your application for registration. **Any such request must be in writing, accompanied by the documentation described in (2), below, and received by the Board within 21 days of the date of this letter of preliminary application denial.**

The Board may grant your request for a hearing if:

- 1) your written request for a hearing is timely received;
- 2) you adequately identify in such written request a specific area of factual dispute relevant to the preliminary denial and have submitted to the Board sufficient credible documentation to establish such dispute;
- 3) the Board determines that a hearing is required to resolve the factual dispute that you have identified; and
- 4) if, following a hearing, the factual dispute were to be resolved in your favor, you would otherwise be eligible for licensure.
