**FRAMEWORK FOR TRAUMA –
INFORMED AND RESPONSIVE PRACTICE**

Vision Statement

The Childhood Trauma Task Force envisions a future in which all organizations and systems in Massachusetts that come into contact with children are trauma-informed and responsive, which means:

- **Adults** working with children realize the widespread impact of trauma on child development, recognize and respond to the impact of traumatic stress on those who have contact with the system, including children, caregivers and service providers, and actively resist re-traumatization.
- **Organizations** infuse an understanding of trauma and its impacts into the organization's culture, policies, and practices, with the goal of maximizing physical and psychological safety, facilitating the recovery of the child and family, and supporting their ability to thrive.

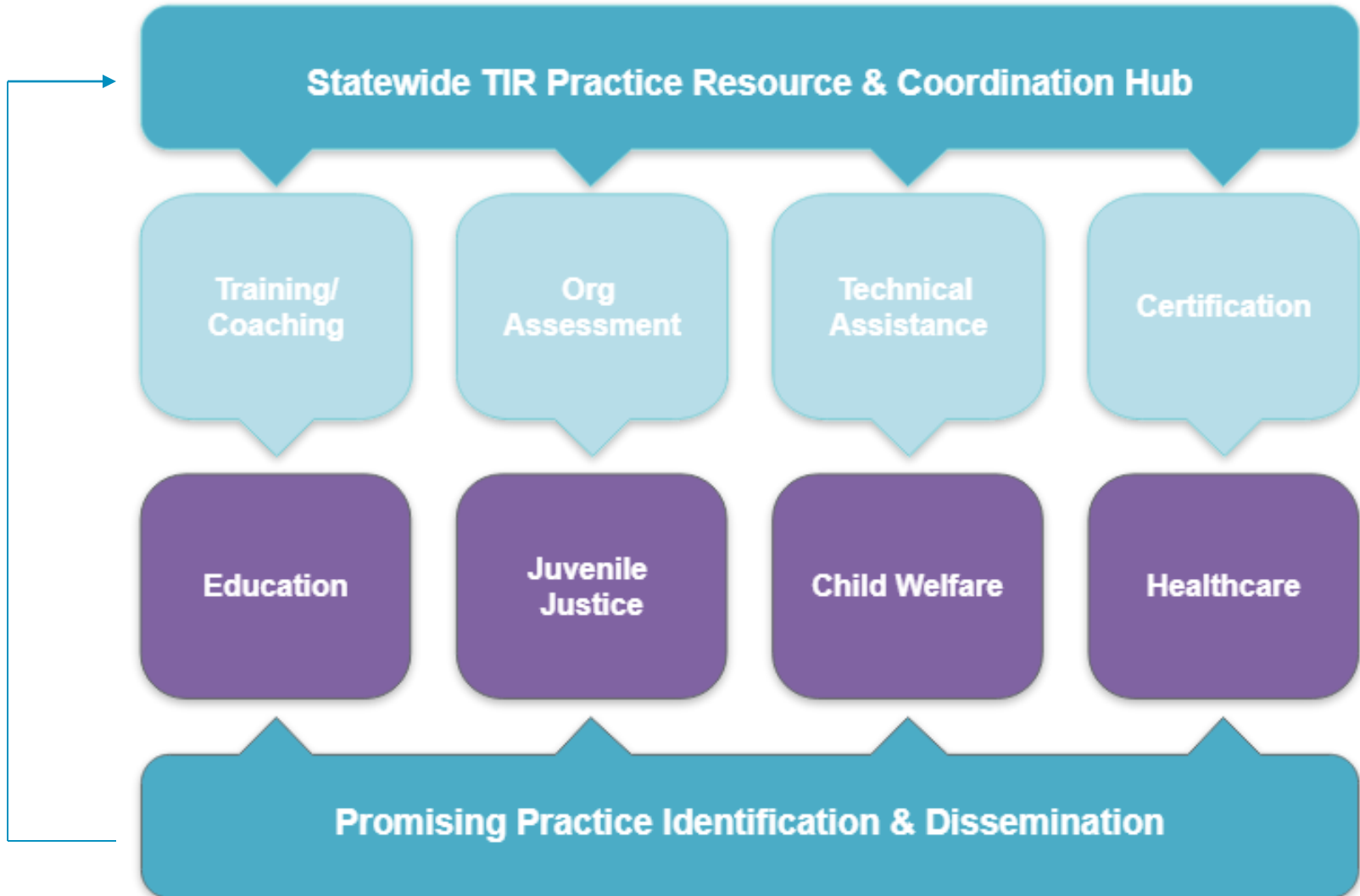
Sector-Specific Implementation Training & Technical Assistance
