EEC Regional Office TIR Training and Communities of Practice

For EEC regional staff

- This **all-day in-person** training provided EEC regional staff with the knowledge and tools to understand how trauma shapes behavior
- Participants worked to **apply this learning** to existing regulatory framework
- Three virtual communities of practice are offered to provide additional information and ongoing technical assistance









Core Champions Train-the-Trainer Program: Deeper Dives in Trauma and Resilience

For selected participants

- A train-the-trainer series is preparing selected applicants to train early childhood educators to extend their trauma-informed and responsive learning further
- Core champion trainers will leave with materials to help support training for providers in their region
- Launched in early February and will be completed in April









Deeper Dives in Trauma and Resilience Early Childhood Educator Training (Regional Training)

For all providers

- Deeper Dives in Trauma and Resilience training will be offered to early education professionals who have completed the initial trainings in the Strong Start LMS
- These trainings will provide participants with extended learning opportunities around the TIR Guiding Principles, real-world application, and practical strategies




Trauma-Informed and Responsive Services for Newcomers

- Two-part training on trauma-responsive practices for schools, 3/12 and 3/19
- Designed to equip K-12 educators with trauma-informed strategies for supporting students who are new to the U.S. or their school communities. Participants will explore how to nurture belonging, strengthen partnerships with families, and understand the impact of trauma on this population.

Agency Interviews Explored:


- What trauma, resilience, and well-being trainings are Massachusetts child-serving state agencies offering to their staff and providers?
- Do child-serving agency staff and providers feel their training needs are being met?
- What additional supports are needed to improve trainings offered?
- What "core" trainings would help improve child-serving professional' knowledge on child wellbeing?





Interviews highlight:

- Differences in agencies' structure and capacity to provide staff training on topics related to childhood trauma and resilience
- Agencies that have standard curriculums and uniform training practices ensure that staff and contracted providers gain the same knowledge or "speak the same language"
- Opportunities for cross-agency collaboration and agency-provider collaboration

National Scan of States' Approaches to Trauma & Resilience Training



Research Questions:

1.How are other states training their child-serving agency staff and contracted partners on childhood trauma, resilience, and wellbeing?

2. What best practices could be implemented in Massachusetts?

Phase 1: General Scan

 National scan of other states' training requirements and opportunities for childserving agency staff and contracted partners.

Phase 2: Trauma and Resilience Scan

 National scan of innovative efforts specific to trauma and resilience trainings for agency staff and contracted providers.



Hawaii's Office of Wellness and Resilience

- Hawaii's Office of Wellness and Resilience (OWR) strengthens state service systems using hopecentered principles as strategies to make Hawaii a trauma-informed state.
- Established in 2023 by the legislature
- Housed in the Governor's Office
- The OWR provides training and technical assistance:
- Offer trainings to executive state departments on the impact of ACEs and STS
- Promote workforce wellness, enhance staff self-care and resilience, and mitigate STS
- Assess and make recommendations for the legislature on policies, practices, programs, and processes to align with trauma-informed care principles



Virginia's Office of Trauma and Resilience Policy

Established by the Department of Social Services (DSS) in 2022:

- Facilitates culture change within DSS to embody traumainformed and hope-centered policy and practice
 - E.g. implementation of the Science of Hope framework, certifying 32
 Hope Navigators
- Promote cross-agency and system-wide collaboration.
 - E.g. Convened a cross-agency Lived Experience Community of Practice
 - E.g. Creation of a Trauma-Informed Initiatives Catalogue to coordinate projects and initiatives statewide
- Lead workforce research efforts
 - E.g. research about vicarious trauma in the DSS human services workforce



Vermont's Agency of Human Services

- 2018 act promotes a coordinated public health approach to addressing childhood adversity and resilience
 - Mandated the creation of the Director of Trauma
 Prevention and Resilience Development position

Statewide

 Direct and coordinate systemic approaches to build resiliency

Agency of Human Services

 Coordinate and improve internal response to childhood adversity, toxic stress, and resilience
