I have reviewed and hereby approve the attached Settlement Agreement by Administrative Consent Order with Penalty and Notice of Noncompliance signed on June 17, 2024, by the Petitioner Cumberland Farms, Inc.'s representative, Nicholas Unkovic and on June 18, 2024, by John Fischer, Deputy Division Director of Solid Waste Management for the Massachusetts Department of Environmental Protection.
