Your Money - Benefit Verifications

99% of the Benefit Verification forms we mailed this year have been returned. Thank you for responding to our request. The next benefit verification process will take place in 2014.

The benefit verification process is required by law and only happens once every two years. Returning your forms right away ensures you avoid any interruption in benefits. Benefit recipients who did not return their forms have


already been contacted by the Board.

Some survivors may have received a form in October from the Group Insurance Commission. These eligibility recertification forms must be returned to the GIC, not the State Retirement Board. They were only sent to survivors who receive health insurance through GIC, not to retirees. The deadline was November 9th. If you have any questions on that form, please call 617-727-2310, ext. 6.

When 2 Weeks Turns into 39 Years

Buyback Manager Sandra Fallon Retires after a Long Career

"I was only coming to work here for two weeks to see how I liked it," said 39 year veteran employee Sandy Fallon. So what exactly happened to make her change her mind? Was it the 12th floor views of downtown Boston? Or was it Taco Tuesday in Ashburton Café inside the state office building? It was neither. Instead she says it was the people she worked with that kept her coming back every day to calculate members' pensions, buybacks, disabilities and even refunds.

Sandy began her career in the Buyback department and moved on to cross-train in both the disability unit and refunds before returning to her original unit as a manager. At the time, the retirement board was going through a transition to computers. The entire workload process up until 1983 was all done by hand. When she returned to Buybacks, the work she was accustomed to was now being done on computers - a challenge she had to overcome. At first the change was unwelcomed, but eventually seeing the screen light up with members' information became a welcomed sight. The computers took away the arduous tasks of researching years of payroll files to come up with the same calculations. When the project was complete and the Board transitioned to doing everything on computers she kept doing the calculations by hand to make sure they were accurate. After a while, she finally trusted the computer calculations. It turns out the computers were a good idea after all.

Sandy enjoyed all the people she worked with through the years and really appreciated the times when everyone helped

each other when work-loads got heavy. She also appreciated the open and helpful work environment and being able to help members access their retirement benefits.

Sandy's legacy is not about comparing mountains of paperwork to computers, but leaving us with tips and advice on how to move forward. "Be dedicated, do your job well, ask questions, help each other, and hunker down when changes are introduced." She advises not to be fearful of new ideas and new ways of doing business. After resisting the onset of computers, she can't imagine doing business without them today!

Although retiring, Sandy will be returning next year on a part-time basis to help out the Board so we can continue to benefit from her years of retirement experience. Good luck Sandy!
