JR's Shamrock, Inc. dba The Shamrock Restaurant & Pub (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, October 2, 2012, regarding an alleged violation of 204 CMR 2.05(2), to wit: c.138, §34- Sale or Delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Keefe's Compliance Check Field Report.

FACTS

- 1. On Wednesday, May 23, 2012, at approximately 6:54 p.m., Investigators Kujawski and Keefe conducted an investigation of the business operation of JR's Shamrock, Inc. dba The Shamrock Restaurant & Pub.
- 2. An underage operative working with investigators purchased an alcoholic beverage, a bottle of Budweiser Lite beer for three dollars (\$3.00). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated of 204 CMR 2.05(2), to wit: c.138, §34- Sale or Delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the licensee has been in business for ten (10) years and has had no previous violations, the Commission issues a **WARNING**.
