DECISION

OHM VARIETY LLC D/B/A GREENRIDGE VARIETY 1086 SOUTH STREET DALTON, MA 01226 LICENSE#: 89413-PK-0262

VIOLATION DATE: 6/26/2024

HEARD: 10/01/2024

Ohm Variety LLC d/b/a Greenridge Variety ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, October 1, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Gardner & Smiddy's Compliance Check Report.

The following documents are in evidence:

- 1. Investigators Gardner & Smiddy's Minimum Purchase Age Compliance Check Field Report, 6/26/2024;
- 2. ABCC Application Summary Review, Transfer of License Approved 10/12/2018;
- 3. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

- 1. On Wednesday, June 26, 2024, at approximately 6:56 p.m., Investigators Gardner and Smiddy ("Investigators") conducted a compliance check at Ohm Variety LLC d/b/a Greenridge Variety.
- 2. An underage operative, working under the supervision of Investigators, purchased alcoholic beverages, a 6-pack of Bud Light beer for nine dollars and twenty-nine cents (\$9.29). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2018 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a WARNING.
