FINAL DECISION

In accordance with the Adjudicatory Proceeding Rules at 310 CMR 1.01(14)(b), Bonnie Heiple, Commissioner of the Massachusetts Department of Environmental Protection ("MassDEP" or "the Department"), has designated me the Final Decision-Maker in this administrative appeal.¹

I have reviewed the attached Settlement Agreement by Administrative Consent Order with Penalty and Notice of Noncompliance, (Enforcement Document No. 00012173, hereinafter referred as "the Consent Order")), signed on November 11, 2021 by Adalton Moreira Sales the Petitioner, and by Douglas Fine, Deputy Regional Director for the MassDEP Central Regional Office on November 23, 2021. Notwithstanding paragraph 26 of the Consent Order, the effective date of the Consent Order/Settlement is the date of this Final Decision.

¹ 310 CMR 1.01(14)(b) provides in relevant part that "[e]very final decision" in an administrative appeal "shall be in writing and shall be signed by the [Department's] Commissioner or a designee of the Commissioner."

Under the terms of 310 CMR 1.01(8)(c), this proceeding is dismissed with the parties waiving whatever rights they may have to further administrative review before the Massachusetts Department of Environmental Protection as well as any appeal to court.
