ORDER OF DISMISSAL

On April 9, 2014, the Appellant, Vladimir Damas (Mr. Damas), filed a bypass appeal with the Civil Service Commission (Commission), contesting his non-selection by the Boston Police Department (BPD) to the position of permanent, full-time police officer.

On April 22, 2014, I held a pre-hearing conference at the offices of the Commission, which was attended by Mr. Damas, his counsel and counsel for the BPD. Based on the documents submitted and the statements of the parties, it is undisputed that:

- Mr. Damas's name appeared on Certification No. 00746 within the 55th "tie-group" of those candidates who signed the Certification as willing to accept appointment if selected.
- While other candidates in the 55th tie-group were appointed, no candidate ranked below Mr. Damas (i.e. – ranked 56th or below) was appointed.

The Commission has consistently held that selection from a group of tied candidates is not a bypass. See Kallas v. Franklin Sch. Dep't, 11 MCSR 73 (1996) ("It is well settled civil service

law that a tie score on a certification ... is not a bypass for civil service appeals"); <u>Bartolomei v.</u> <u>Holyoke</u>, 21 MCSR 94 (2008) ("choosing from a group of tied candidates does not constitute a bypass"); <u>Coughlin v. Plymouth Police Department</u>, 19 MCSR 434 (2006) ("the Commission ... continues to believe that selection among a group of tied candidates is *not* a bypass under civil service law') (*emphasis in original*); <u>Edson v. Town of Reading</u>, 21 MCSR 453 (2008) ("When two applicants are tied on the exam and the Appointing Authority selects one, the other was not bypassed"), decision affirmed by Superior Court, <u>see Edson v. Civil Serv. Comm'n</u>, Middlesex, Sup. Crt. No. 08-CV3418-F ((2009); see also <u>Cotter v. Boston</u>, 193 F. Supp. 2d 323, 354 (D. Mass. 2002), rev'd in part on other grounds, 323 F.3d 160 (1st Cir. 2003) ("when a civil service exam results in a tie score, and the appointing authority ... promotes some but not all of the tied candidates, no actionable 'bypass' has taken place in the parlance of the Civil Service Commission.")

BPD subsequently filed a Motion for Summary Decision (which I have deemed a Motion to Dismiss) seeking to dismiss Mr. Damas's appeal. No reply was received from Mr. Damas.

For all of the reasons cited in BPD's motion, including that no bypass occurred here, Mr. Damas's appeal under Docket No. G1-14-86 is hereby *dismissed*.
