## **DECISION**

LA-BELLE MANAGEMENT LLC DBA CARDOZA'S WINE & SPIRIT 154 FAUNCE CORNER ROAD DARTMOUTH, MA 02747 LICENSE#: 026600082

La-Belle Management LLC dba Cardoza's Wine & Spirit (the "Licensee") holds an alcohol beverage license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, December 16, 2014, regarding the alleged violation of M.G.L. c. 138, §34 - Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age (1 Count). Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Velez's Report.

## **FACTS**

- 1. On Friday, September 19, 2014, at approximately 7:00 p.m., Investigators Binienda and Velez investigated the business operation of La-Belle Management LLC dba Cardoza's Wine & Spirit to determine the manner in which its business was being conducted.
- 2. Investigators conducted surveillance outside the licensed premises and observed two youthful looking individuals (one male and one female) exit the premises.
- 3. Investigators observed the male individual carried a 12-pack of Shocktop beer and a brown paper bag which was found to contain one 750 ml bottle of Bacardi Wolf Berry rum.
- 4. Investigators asked the male individual for identification. He supplied a Connecticut Driver's License in his name, Tyler Sousa, with date of birth (age 22).
- 5. Investigators asked the female individual for identification. She supplied a Connecticut Driver's License in the name of Vrianna Bruhn, date of birth (age 21).
- 6. Investigators examined the Connecticut Driver's Licenses, and based on their training and experience, determined that both were fraudulent.

- 7. Investigators then asked the individuals for their true identities, and they each presented investigators with a Massachusetts <u>Driver's License</u>.
- 8. Tyler Sousa, actual date of birth (age 20), and Brianna Bruhn, actual date of birth (age 19).
- 9. Investigators identified Mr. Sousa to the clerk on duty, Simone Longoria.
- 10. Investigators informed Ms. Longoria of the violation and that a report would be filed with the Chief Investigator for further action.

## **CONCLUSION**

Based on the evidence, the Commission finds the licensee violated of M.G.L. c. 138, §34 - Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age (1 Count). Therefore, the Commission suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
