**Subject:** **RESEA Webinars - Implementation of the Policy and Procedure Updates**

---

**Purpose:** To notify Local Workforce Development Boards, One-Stop Career Center Operators and other workforce development partners of upcoming RESEA Webinars.

These webinars will focus on two primary policy changes issued in Policy # 100 DCS 23.100.1, dated November 21, 2017: *Reemployment Services and Eligibility Assessment (RESEA) Policy and Procedures Manual - Updated*

As part of that Policy and in response to the Massachusetts Consolidated Review, there were items brought to our attention that required additional focus. The issuance's action item included notice to pay particular attention to:

1. *RESEA UI Eligibility Assessment Questionnaire* (MWF Policy Issuance 100 DCS 23.105) - now 23.105.1

2. The UI requirement regarding referrals to additional services, follow up on those services and the UI feedback loop for those who fail to participate/attend.

**Background:** The Re-Employment Services and Eligibility Assessment (RESEA) program provides selected RESEA customers with an introduction to a full array of re-

employment services available at Massachusetts One-Stop Career Centers and refers them to appropriate employment opportunities and re-employment services suitable to their individual needs. The RESEA program ensures that RESEA customers are in full compliance with their UI eligibility requirements.

The U.S. Department of Labor requires all RESEA customers to be assessed for UI eligibility at each RESEA meeting (Initial RESEA and RESEA Review).

The purpose of the UI eligibility assessment is to identify any unemployment insurance eligibility issues, or potential issues, and refer those identified to the Department of Unemployment Assistance for review and/or adjudication.
