| | Sunset Provisions of the Trade Adjustment Assistance Extension Act of 2011 |
| | program became effective and are referred to as "Reversion 2014". The |
| | Trade Adjustment Assistance Reauthorization Act of 2015 (TAARA 2015) was |
| | signed into law by President Obama on June 29, 2015. TAARA 2015 repeals |
| | the sunset provision of the Trade Adjustment Assistance Extension Act of |
| | 2011 (TAAEA), under which the Reversion 2014 Program which had been in |
| | effect since January 1, 2014. |
