Subject: LGBTQ+ Customers and the Workplace Training

- **Purpose:** To notify MassHire Workforce Boards, MassHire Career Center Operators, MassHire Career Center Directors, Operations Managers and Career Center staff of the two-part training series, "*LGBTQ+ Customers in the Workplace*". The sessions are scheduled for June 10, 2021 and June 24, 2021 from 10:30am to 12:00pm, each day.
- **Background:** The MassHire Department of Career Services has collaborated with PFLAG Boston, the first and largest organization for lesbian, gay, bisexual, transgender, and queer (LGBTQ+) people, their parents and families, and allies. PFLAG works directly with stakeholders in their communities, providing training, support, resources, creative programs, and model policy to create an environment of respect.

The training will include the following topics:

Part I – Thursday, June 10, 2021

• Definition of acronyms, terminology and identity labels used by and about lesbian, gay, bisexual, transgender, queer/questioning, plus (LGBTQ+) individuals and 'communities'

- Federal and Massachusetts Nondiscrimination Laws
- LGBTQ+ success in the workplace and distinct workforce service needs
- Intersectionality: Crossroads of identities within the LGBTQ+ 'community' and successful employment
- Guest Speaker(s)/Panel Discussion: Multiple viewpoints of LGBTQ+ people's lived experiences

Part II – Thursday, June 24, 2021

- Creating opportunities for support and welcoming environments/Allies
- Guest Speaker(s)/Panel Discussion: Multiple viewpoints of LGBTQ+ people's lived experiences around customer service and the workforce
- Enhancing inclusion and excellence in MassHire Service Delivery to our LGBTQ+ customers
