Keynote speaker: Dr. Richard Pimentel is a nationally renowned disability inclusion trainer known for his ability through storytelling and humor to entertain, inspire, challenge the audience, while being respected and most importantly understood.

He is the primary author of The Windmills Changing the Perception of Ability training program. Over 150 individuals in Massachusetts have been trained as trainers in Windmills over the past two years.

Dr. Richard Pimentel will speak on

- His life story as a disabled Vietnam veteran
- The importance of including individuals with disabilities in all aspects of workforce initiatives, cohorts, partnerships, and services.
- The importance of The Massachusetts Rehabilitation Commission in partnership with MassHire, Career Centers and Massachusetts Community Rehabilitation Programs effectively working together to meet the disability inclusion needs of the business community to hire and retain individuals with disabilities in Massachusetts.
- The important steps needed to build effective partnerships within our state and community partners and ensure that the strengths, abilities, and needs of workers with disabilities are considered and included when planning and implementing workforce services, initiatives, and programs.

Virtual Training (7 Regional Sessions) Disability Inclusion: Building the Team Approach of Services for the Business Community

Presenters: Dr Richard Pimentel and Milt Wright

Participants: Representatives supporting disability inclusion services from Americas Job Centers (AJCs), Community Rehabilitation Programs (CRPs), MassHire, Massachusetts Rehabilitation Commission (MRC), and Windmills Trainers

The business community seeks a coordinated service delivery to increase the recruitment and hiring of persons with disabilities.

Participants will gain an understanding of how each of the four organizations operate and work with program participants and employers to effectively work as a team to meet the need of businesses.

The key objective is to collaborate on a strategic plan for a team approach of Americas Job Centers (AJCs), Community Rehabilitation Programs (CRPs), MassHire, and Massachusetts Rehabilitation Commission (MRC) to collectively address disability inclusion and the needs of the business community to recruit and hire people with disabilities.

A completed data call questionnaire will be collected from the regional programs prior to the training. The content includes:

- Region
- Organization name, address, website, contact information
- Program mission, goals and objectives
- Description of services and process for:
 - Consumer/Client Services for PWD List of services and link to service resources
 - Business/Employer Services List of services and link to service resources

- Process of Service Delivery Links to Steps/Flowchart of Process (if available)
- Key disability services POCs main point of contact, title and contact information
- o Disability services staffing roles of responsibilities Define roles
- Description of current challenges and proposed solutions to collaborate between America Job Center (AJC), Community Rehabilitation Programs (CRP), MassHire, and Massachusetts Vocational Rehabilitation (MVR) services for the employment and retention of people with disabilities

All participants in these regional sessions will receive the description of the services of each of the programs participating.

The interactive sessions will support:

- Learning from each other their enrollment and service delivery process, and how they are currently working with the business community
- Facing the challenges to overcome
- Discussing proposed solutions
- Developing implementation strategies to work together as a team
