**Purpose:** To notify MassHire Workforce Boards, MassHire Career Center Operators and

other local workforce partners of the availability and posting of FY25 Innovation

Career Pathways Grants.

**Background:** Innovation Career Pathways are designed to create strong partnerships with

employers in order to expose students to career options and help them develop knowledge and skills related to their chosen field of study before they graduate

high school.

Two funding opportunities for FY25 Innovation Career Pathways Grants are now available.

FY25 0419 Innovation Career Pathways Implementation Competitive RFP.

The purpose of this competitive grant is to provide designated Innovation Career Pathways with resources to support program implementation. <u>If you</u>

are a 2024 designee and/or a designee from 2020-23, you are eligible for this grant. You will only need to do one submission regardless of number of pathway designations.

<u>FY25 0436 Innovation Career Pathways Planning Competitive RFP</u>. The
purpose of this competitive grant is to provide Innovation Career Pathway
program resources to an LEA who intends to seek Innovation Career Pathway
designation from DESE process beginning Fall 2024. Eligible applicants are all
Massachusetts public school districts, including charter schools, regional
school districts, collaboratives, approved special education schools and other
LEAs.

Grant applications must be submitted through the DESE <u>Grants for Education</u> <u>Management System (GEM\$)</u>.

Proposals must be received at the Department by 5:00 p.m. Eastern on the date due. Competitive Grants cannot be accepted after the due date.

## About GEM\$

- GEM\$ is a cloud-based fiscal and program management grant system.
- Each district has established a user administrator for GEM\$. Please connect
  with your finance/business office to let them know you wish to apply for this
  grant. You may contact Jennifer Gwatkin if you need this individual's contact
  information.
- As GEM\$ has a workflow, which requires individuals other than the "grant writer" to approve (business manager, superintendent), please plan accordingly to ensure a timely submission.
