Honorable Chairs and Ranking Minority Members of the Committees on Ways and Means:

Pursuant to Section 6 of Chapter 14 of the General Laws¹, the Department of Revenue (DOR) hereby submits its mid-month tax revenue report for the month of December 2018, the sixth month of fiscal year 2019. The attached table shows December 2018 month-to-date tax revenue collections through December 14, 2018, along with changes from the equivalent period in December 2017.

Revenue collections are uneven and weighted toward month-end, and the brief period covered in the midmonth does not provide sufficient data for comparison to prior years. **Therefore, the Department strongly urges that mid-month figures should not be used to assess trends or project future revenues.**

Context for December estimates

In recent years, December has contributed an average of 9.5% of total annual collections, ranking number five among the twelve months of the year for share of collections. Estimated Payments for Corporate & Business Taxes are due in the month. Although Estimated Payments for individuals are not due until January, there is also considerable inflow in this category each December. This is largely due to individuals choosing to make the January payment early, in order to claim the related deduction on their 2018 federal taxes.

Highlights

- **Total Tax** collections for the month-to-date period were \$965 million, up \$128 million or 15.3% versus the same period in December 2017.
- **Income Taxes** totaled \$641 million, up \$114 million or 21.6% versus the same period in December 2017.
- Sales & Use Tax collections were \$80 million, up \$4 million or 6.0% versus the same period in December 2017.
- **Corporate & Business Taxes** were \$175 million, down \$4 million versus the same period in December 2017.
- Other Taxes totaled \$70 million, up \$14 million versus the same period in December 2017.

Detail

Total Income Tax of \$965 million for mid-month December comprises the following:

- **Withholding** of \$616 million, up \$140 million from mid-month December 2017. Some of the month-to-date increase in withholding may have been borrowed from the remainder of the month.
- Estimated Payments of \$32 million, down \$20 million from mid-month December 2017.
- **Returns/Bills** of \$16 million, up \$1 million from mid-month December 2017.
- **Refunds** of \$24 million, up \$8 million from mid-month December 2017. Because refunds are an outflow, this represents a negative variance from the prior year.

Sales & Use Tax collections of \$80 million for the December month-to-date period are \$4 million or 6.0% more than the equivalent period last year. Only a small proportion of expected Regular Sales and Meals tax remittances, subcategories of Sales & Use Tax, are received by the mid-month date; the bulk of these payments are expected on or after the 20th of the month.

- \$34 million in Regular Sales Tax collections, up \$1 million from mid-month December 2017.
- \$12 million in Meals Tax revenues, up \$1 million from mid-month December 2017.
- \$34 million in Motor Vehicle Sales Tax revenues, up \$2 million from mid-month December 2017.`

Corporate & Business tax revenues were \$175 million, down \$4 million from mid-month December 2017.

All Other includes a number of tax categories including motor fuels, cigarettes, estate taxes, and deeds. All other revenues were \$70 million, up \$14 million from mid-month December 2017.

Because collections are weighted to the end of the month, we do not use the mid-month figures to project full-month revenue. Comparisons to prior-year periods are unreliable because of normal fluctuations and calendar differences in the short 15-day window of incremental data.
