Honorable Chairs and Ranking Minority Members of the Committees on Ways and Means:

Pursuant to Section 6 of Chapter 14 of the General Laws¹, the Department of Revenue (DOR) hereby submits its mid-month tax revenue report for the month of December 2023, the sixth month of fiscal year 2024. The attached table shows December 2023 month-to-date tax revenue collections through December 15, 2023, along with changes from the equivalent period in December 2022.

Revenue collections are uneven and usually weighted toward month-end. Therefore, mid-month figures should not be used to assess trends or project future revenues.

Context for December Revenues

December is a significant month for revenues because many corporate and business taxpayers are required to make quarterly estimated payments. In addition, some quarterly income estimated payments due by January 15th may be received in December. Historically, roughly 9.5% of annual revenue, on average, has been received during December.

Highlights

Total Tax collections for the month-to-date period were \$1.544 billion, \$138 million or 8.2% less than the collections during the same period in December 2022. December results show decreases in all major tax types except withholding.

- **Income Taxes** totaled \$889 million, down \$30 million or 3.2% versus the same period in December 2022.
- Sales & Use Taxes totaled \$143 million, down \$2 million or 1.5% versus the same period in December 2022.
- **Corporate & Business Taxes** totaled \$474 million, down \$63 million or 11.7% versus the same period in December 2022.
- Other Taxes totaled \$39 million, down \$44 million or 53.1% versus the same period in December 2022.

Details

Total Income Tax of \$889 million for mid-month December is comprised of the following:

- Withholding of \$775 million, up \$31 million versus the same period in December 2022;
- Estimated Payments of \$133 million, down \$1 million versus the same period in December 2022;
- **Returns/Bills** of \$47 million, down \$12 million versus the same period in December 2022; and
- **Refunds** of \$66 million, up \$48 million (unfavorable) versus the same period in December 2022.

Sales & Use Tax of \$143 million is down \$2 million versus the same period in December 2022. Typically, only a small proportion of expected regular sales and meals tax remittances are received by the mid-month date. The month-to-date sales and use tax of \$143 million is comprised of the following:

- **Regular sales** tax of \$63 million, down \$5 million versus the same period in December 2022;
- Meals tax of \$29 million, up \$2 million versus the same period in December 2022; and

• Motor vehicle sales tax of \$52 million, up \$1 million versus the same period in December 2022.

Corporate & Business Tax of \$474 million is down \$63 million versus the same period in December 2022. The month-to-date decrease is primarily due to decreases in estimated and returns payments, partially offset by a favorable decrease in refund.

Other Taxes of \$39 million, down \$44 million versus the same period in December 2022, includes a number of tax categories, such as motor fuels, cigarette, estate tax, room occupancy, and deeds.
