## HUMAN RESOURCES

#### **Staffing Updates**

We are currently recruiting to fill two key open positions at the GIC.

- **Government Affairs Manager** this position will report to Erika Scibelli, the GIC's Deputy Executive Director, and will focus on legislative and municipal activities.
- **Counsel I** this position will report to Andrew Stern, the GIC's General Counsel, and will support the agency and the Legal Department on a range of legal functions.

#### **GIC Office Space Move**

At the end of November, the GIC successfully completed a long-awaited move of our office space from the 16<sup>th</sup> floor of 1 Ashburton Place to suite 1413 on the 14<sup>th</sup> floor of the same building. The new office space was designed to meet the Commonwealth's Future of Work standards, conducive to a hybrid work environment. GIC employees will continue with their current hybrid work models and schedules. The move went very smoothly under the leadership of Karen Jenkins and Maureen Quinn who carefully coordinated with all GIC departments and staff as well as DCAMM, EOTSS and other state agencies to ensure that the GIC's needs were met and executed smoothly.

#### **Legislative**

The Legislature remains fairly quiet following Fall election, but staff will continue to closely monitor legislative activities in the last weeks of the current session. The pace will pick up in the new year with the beginning of a new biennial session and the start of budget season with the release of H1 in late January.

### **Municipal**

As of December 1, 2024, one new municipality (Holliston) will be joining the GIC for plan year July 1, 2025. Staff will meet with Holliston officials in January to begin the onboarding process. No municipalities will be leaving the GIC.
