About the Inter-Agency Task Force



The Task Force was established by Executive Order 625 earlier this year to ensure that Massachusetts leads the nation in early education and child care access, affordability, equity, and quality. The Task Force has a 3-year timeline.



The Task Force is comprised of the Secretary of Education, the Secretary of Labor and Workforce Development, and the Secretary of Economic Development, who shall serve as co-chairs. Additional members of the Task Force are the Secretaries of Administration and Finance, Energy and Environmental Affairs, Health and Human Services, Housing and Livable Communities, Public Safety and Security, Technology Services and Security, Transportation, and Veterans Services, or their designees.



In developing its recommendations, the Task Force will engage with industry and business leaders, organized labor, health services stakeholders, housing and planning experts, working parents and caregivers, and child care providers and experts.

Innovative

Are we welcoming out-of-the-box ideas to capitalize on fresh perspectives from all executive offices and stakeholders?

Child-Centered

Do the solutions advance academic and social-emotional development for our learners?

Equitable

- ③ Identifying resources for building capacity and increasing affordability in the early education and child care system
- ④ Identifying strategies to recruit, train, upskill, and retain members of the early education and child care workforce
- ⑤ Reviewing existing assets to identify potential locations to establish center-based early education and child care

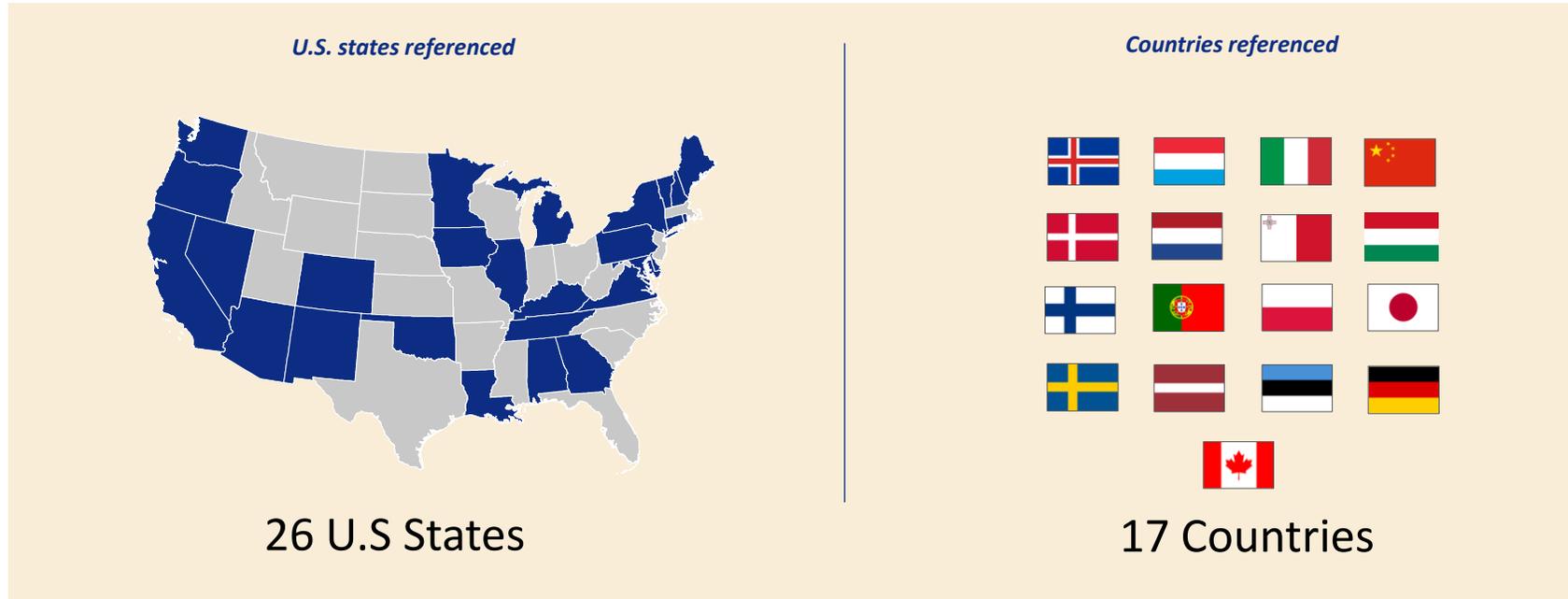
What the Task Force Heard from the Community

Some key themes:

- There is a strong sense of commitment across government, philanthropy, business, and the early education and child care sector to expand and deepen system-wide solutions.
- Affordability is a pressing issue for families across the state.
- Accessible early education and child care is a challenge.
- Providers are struggling with high operating costs, which impact their ability to run sustainable businesses and attract talent.
- There is an important opportunity to build the public's appreciation and respect for the critical role early educators play in the healthy development of young learners.
- Expansion of universal access to preschool needs to continue through the mixed-delivery model, in order to create true equity in opportunity, maximize family choice, and maintain financial stability for programs serving infants and preschoolers.
- The Administration should continue to reduce administrative burdens, modernize systems, and improve communication for families, programs, and educators.
- Mental and behavioral health support is critical for children, parents and caregivers, and programs.

FY25 CCFA Reimbursement Rate Increase – Overview & Options for Consideration

Child Care Financial Assistance Rates

EEC reimburses early education and out-of-school time programs that serve families receiving EEC child care financial assistance with a daily per child reimbursement rate.

These rates subsidize costs and provide purchasing power for families receiving child care financial assistance.

EEC's daily reimbursement rate for child care financial assistance is based on multiple factors including:

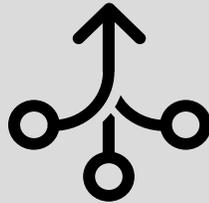

FY24 CCFA Rate Increases and Changes

In FY24, for the first time, the EEC Board approved transformative changes to CCFA rates, informed by the cost of care, including:



5.5% across-the-board increase.



Consolidation of rates across regions with similar costs.



Targeted adjustments to rates by region and age group that made significant progress on long-standing inequities in rate amounts, using both market rate survey and cost of care findings.

After the rate increase in FY24, all rates were at least 72% of the 2022 estimated cost of care.

FY25 Update: Use of Federally Approved Cost-Informed Methodology in Massachusetts

- EEC received federal approval in January 2024 from the Office of Child Care (OCC) to develop and execute a cost-based alternative methodology to inform adjustments to child care financial assistance rates.
 - EEC contracted with the American Institutes for Research (AIR) in May 2024 to update, refine, and expand cost models.
 - As part of alternative methodology proposal and CCDF plan, EEC committed to implementing CCFA rate adjustments that are informed by an updated estimate of the cost of care by Spring 2025, pending available resources.
 - EEC is on track to meet this timeline.
 - A final report summarizing findings from the 2024 cost study and how the cost of care methodology informed CCFA rate adjustments this year will be complete by Spring 2025.

Recap from November Board Meeting: What Is a Cost Model?

- Estimates the per-child cost to operate a child care program, by different program types, regions, ages of children served, and other program characteristics.
 - This is not the same as what programs *charge* for care (tuition).
 - This is not the same as a *budget* (a spending plan that does not typically include volunteered/donated resources).
- Represents the most typical classroom and staffing configurations of early education and care programs.
 - Will not represent the unique configurations of *every* program.
- Findings from cost models can be used to inform state-level funding and policy decisions.

Recap from November Board Meeting: FY25 Cost Study Phases

Phase 1 May 2024–December 2024

- Revisit 2022 cost model assumptions and inputs.
- Engage with stakeholders, including educators.
- Update 2022 cost model prices for every input.
- Estimate per-child costs by region, program type, and age.

Phase 2 October 2024–June 2025

- Make additional refinements to model assumptions and structure.
- Increase focus on school-aged care estimates.
- Explore cost inputs for informal care settings.
- Explore how comprehensive services can be represented in the models.
- Make additional updates to the cost of aspirational care model.
- Continue to engage with key stakeholders and early education and care programs.

Recap from November Board Meeting: AIR Methodology for Cost Model Updates

- The AIR research team updated the three cost models developed in 2022:
 - Two center-based models: current cost of care and aspirational cost of care
 - One FCC model: hybrid of current costs and aspirational compensation
- The ingredients approach (Levin et al., 2018) was used to estimate the value of the resources used to provide early education and care across Massachusetts.
- All 2022 model prices were adjusted to 2024 dollars.
- When possible, multiple data sources were triangulated to arrive at the best price estimate.

Recap from November Board Meeting: Notable Cost Increases From 2022 to 2024

- The cost of care per child for center-based programs increased between **14%** and **26%** between 2022 and 2024, depending on the region and age group served.
- The cost of care per child for family child care (FCC) programs increased between **12%** and **19%** between 2022 and 2024, depending on the region and age group served.
- The percent change in per child costs from 2022 to 2024 did not vary significantly across regions.

FY25 Rate Increase Options

FY25 Budget: Rate Increase/Reserve Language

1596-2434 Rate Increase for Early Education and Care language from the Acts of 2024, Chapter 140, Section 2F

For a reimbursement rate increase for subsidized early education and care for salaries, benefits and stipends for professional development of early educators; provided, that rate increases funded from this reserve shall support, as well as increase access to care for families; provided further, that funds appropriated in this item shall be used to increase the reimbursement rate by an appropriate percentage for all such providers; provided further, that funds shall be expended for increasing the daily add-on rate for comprehensive early education services for children with active cases at the department of children and families; provided further, that the commissioner of early education and care may transfer funds between this item and items 3000-3060 and 3000-4060, as necessary, for this purpose, under an allocation plan that shall detail, by object class, the distribution of the funds to be transferred and which shall be submitted to the house and senate committees on ways and means not less than 30 days before any such transfer; provided further, that \$45,000,000 shall be expended to annualize rate increases implemented in fiscal year 2024; and provided further, **that \$20,000,000 shall be expended for additional rate increases for subsidized early education center-based and family child care providers in fiscal year 2025..... \$65,000,000**

FY24 Close Out Supplemental Budget: Rate Increase/Reserve Language

3000-1142 Rate Reserve language from FY24 Close Out Supplemental Budget from the Acts of 2024, Chapter 193, B.H5077

For a reimbursement rate increase for center-based subsidized early education and care for salaries, benefits and stipends for professional development of early educators; provided, that funds appropriated in this item shall be used to increase the reimbursement rate by an appropriate percentage for all such providers; provided further, that funds shall be expended for increasing the daily add-on rate for comprehensive early education services for children with active cases at the department of children and families; provided further, that the commissioner of early education and care may transfer funds between items 3000-3060 and 3000-4060 of section 2 of chapter 140 of the acts of 2024 , as necessary, for this purpose, under an allocation plan that shall detail, by object class, the distribution of the funds to be transferred and which shall be submitted to the house and senate committees on ways and means not less than 30 days before any such transfer... **\$2,500,000**

Guiding Principles for FY25 Rate Proposal



Use a **cost-based** methodology to inform adjustments to child care financial assistance rates.

- Continue to **prioritize** child care financial assistance **rates** that are **furthest from the cost of care**.



Acknowledge **increased costs** for all programs.

- Use portion of funds for cost-of-living-adjustments (COLA)



Distribute resources proportionally to where CCFA children are receiving care by program type and region.



Recognize **differences between** the compensation assumptions in the **center-based** (based on current salaries) **and FCC cost model** (based on more aspirational salaries).

Proposed Allocation of FY25 Rate Reserve

- We have explored two options for a targeted rate increase which consider both the cost of care findings and distribution of children by setting type (center-based and family child care), and compliance with line-item language.

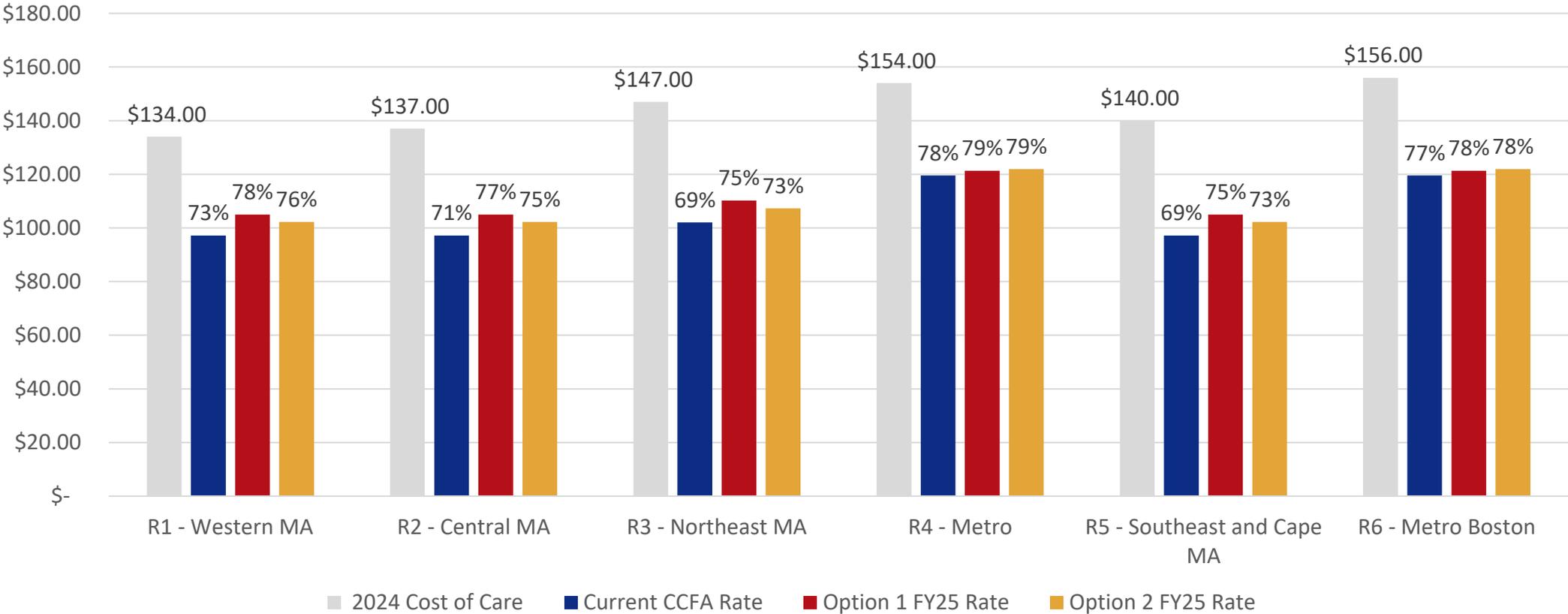

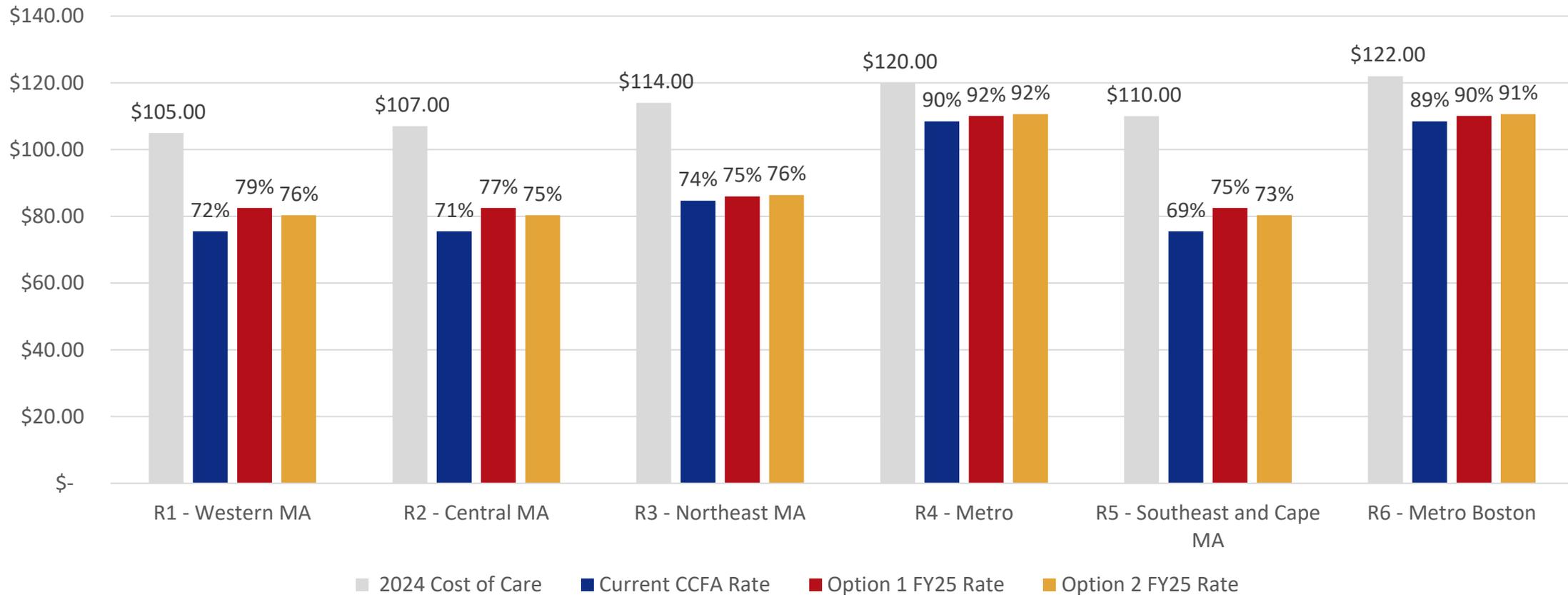
Both FY25 rate proposals direct resources towards center-based infant rates across regions, and Option 1 further increases these rates in four regions that are the farthest from the cost of care.

Infant CCFA Rates as a Percent of Cost of Care by FY25 Rate Increase Option and Region



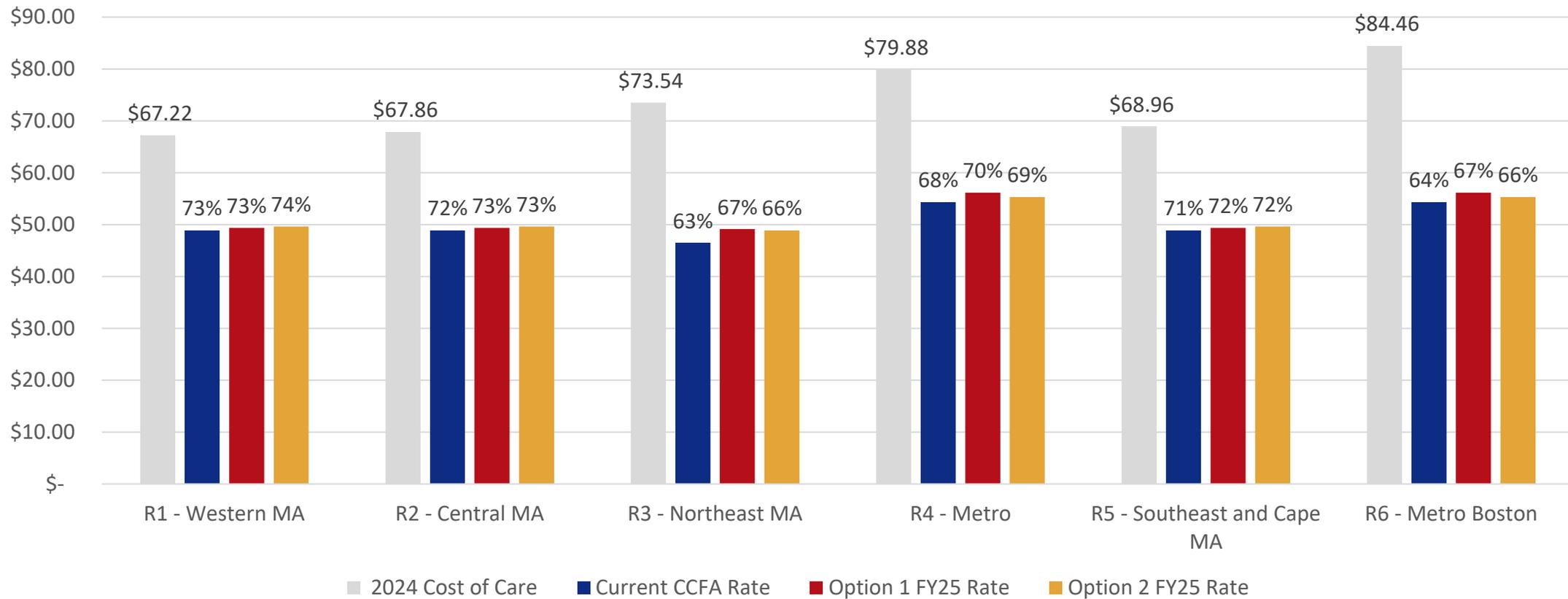
Both FY25 rate proposals direct resources towards center-based toddler rates across regions, and Option 1 further increases these rates in three regions that are the farthest from the cost of care.

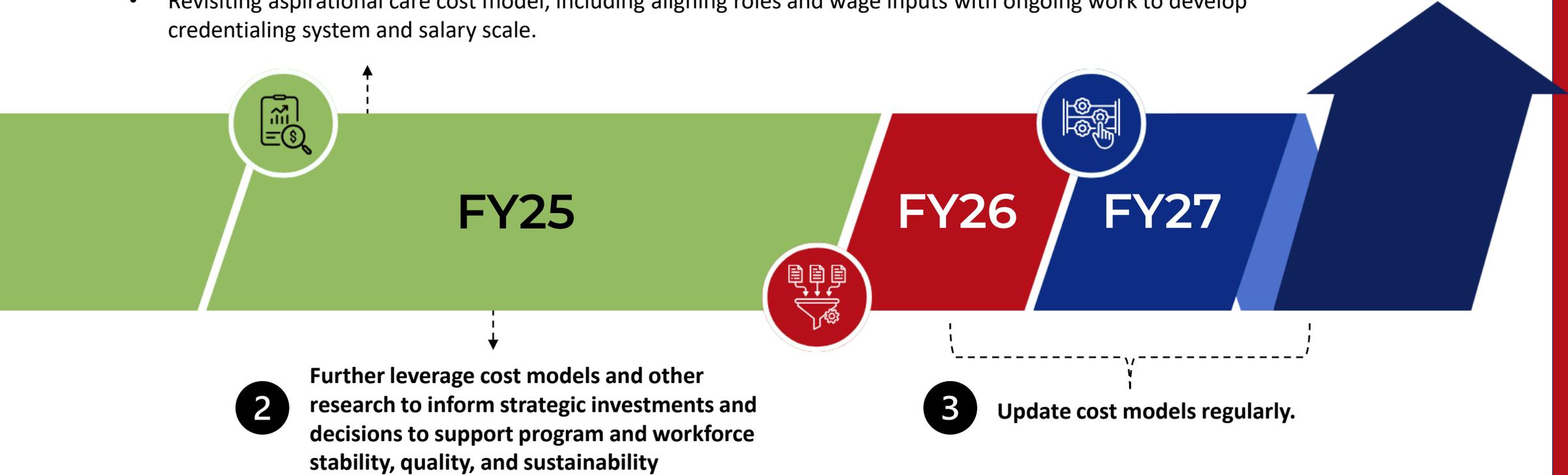
Next Steps & Looking Forward

Priorities include (and are not limited to):

- Examining cost of additional services to children and families including behavioral and mental health supports and comprehensive services
- Further refining school-age care inputs and assumptions.
- Revisiting aspirational care cost model, including aligning roles and wage inputs with ongoing work to develop credentialing system and salary scale.

Further leverage cost models and other research to inform strategic investments and decisions to support program and workforce stability, quality, and sustainability
