After a hearing on October 1, 2024, the Commission finds Patriot Spirits Inc., d/b/a Liquor 'N More in Dennis, License # 00012-PK-0278, violated M.G.L. c 138, § 18 – Acting as a § 18 wholesale licensee without being properly licensed.

The Commission **SUSPENDS the license of Liquor 'N More in Dennis, License # 00012-PK-0278, for a period of twenty (20) days of which five (5) days will be served and 15 days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations are found by this Commission.**

**The suspension shall commence on Monday, January 5, 2026, and terminate on Friday, January 9, 2026.** The license will be delivered to the Local Licensing Board or its designee on Monday, January 5, 2026, at 9:00 A.M. It will be returned to the licensee on January 10, 2026.

You are advised that pursuant to the provisions of M.G.L. c. 138 § 23, you may petition the Commission to accept an offer in compromise in lieu of suspension within twenty (20) calendar days following such notice of such suspension. After a hearing on October 1, 2024, the Commission finds Patriot Spirits Inc., d/b/a Liquor 'N More in Dennis, License # 00012-PK-0278, violated M.G.L. c 138, § 18 – Acting as a § 18 wholesale licensee without being properly licensed.

The Commission **SUSPENDS the license of Liquor 'N More in Dennis, License # 00012-PK-0278, for a period of twenty (20) days of which five (5) days will be served and 15 days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations are found by this Commission.**

Patriot Spirits, Inc. d/b/a Liquor 'N More located in Plymouth and South Dennis ("Licensees", "Patriot Spirits" or "Liquor 'N More") holds alcoholic beverages retail package store licenses issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a hearing on Tuesday, October 1, 2024, regarding alleged violations of:

- 1) M.G.L. Ch. 138, § 23 Unlawful Purchase: No license issued under §§ 12, 14, or 15, and no certificate of fitness issued under § 30 shall authorize the sale of any alcoholic beverages other than those purchased from a licensee under §§ 18, 19, or 19F or 19C or from a holder of a special permit to sell issued under § 22A, which occurred from April 24, 2023, to June 29, 2023; (88935-PK-0984)
- 2) 204 CMR 2.05 (3) The person in charge of any vehicle used for the delivery of alcoholic beverages or alcohol shall carry an invoice or sales slip, stating the names and addresses of the purchaser and seller, the date and the amount of the purchase, and also itemizing the number of the various kinds of containers and the kinds, quantities, and brands of alcoholic beverages or alcohol, which occurred from April 24, 2023, to June 29, 2023; (88935-PK-0984)
- 3) M.G.L. c 138, § 18- Acting as a § 18 wholesale licensee without being properly licensed. (00012-PK-0278)

The alleged violations occurred Monday, April 24, 2023, to June 29, 2023.

FINDINGS OF FACT

1. Patriot Spirits, Inc. d/b/a Liquor 'N More holds multiple alcoholic beverages retail package store licenses issued pursuant to M.G.L. c. 138, § 15 as permitted by law including, but not limited to, license #00012-PK-0278 located at 500 Route 134, Dennis, and license # 88935-PK-0984 located at 35 Home Depot Drive, Plymouth, MA 02360. (Exhibit 14)
2. On April 24, 2023, this Commission received a complaint regarding consolidated buying by Patriot Spirits, Inc. and the shipping of inventory amongst licensed premises. Id.
3. On May 24, 2023, Investigators Gardner and Terasconi ("Investigators") investigated the April 24, 2023, complaint against Liquor 'N More located at 35 Home Depot Drive, Plymouth, Massachusetts. Id.

4. Investigators entered the licensed premises, asked to speak with the manager, later identified as Marty, and informed him of the complaint. Marty admitted alcoholic beverages are transferred among the Liquor N More locations, and what they are doing is not unlawful. Marty indicated there were four Liquor N More locations in Plymouth, Dennis, Orleans, and Wareham, and that the transfers of alcoholic beverages occur on a weekly basis, typically on Thursdays, using a Liquor 'N More vehicle. Id.
5. Investigators then entered the storage room of the Plymouth location and observed boxes of alcoholic beverages stacked in groups with documents attached labeled, "Unposted Transfers Outs." Id.
6. The document on one group of boxes had markings which indicated, From: Liquor N More Plymouth 35 Home Depot Drive to Liquor N More Orleans 9 West Road. The document listed an item number, description, quantity documented as well as blank lines for "Quantity received, From loc price, and From ext retail." Id.
7. The document on a second group of boxes had markings which indicated, From Liquor N More Plymouth 35 Home Depot Drive to Liquor N More Dennis 500 Route 134. Id.
8. Investigators asked Marty who produced and provided the "Unposted Transfer Outs" documents. Marty replied that he received these documents via email from the owner, Michael Patterson. Id.
9. Investigators also observed two ledgers which detailed the quantity and brands of alcoholic beverages being transported from the Plymouth licensed premises to the Dennis and Orleans licensed premises. (Exhibits 5, 8, 14)
10. Investigators then contacted Mr. Patterson and arranged to meet with him and his attorney, Daniel Chamberlain, to address this complaint. (Exhibit 14)
11. Atty. Chamberlain stated that the Licensees have dealt with this type of complaint in the past and what Patriot Spirits Inc. is doing is not unlawful because all the licensed premises are under the same ownership. Id.
12. Investigators informed the Licensees and their attorney of the Commission's 2017 Consolidated Buying Advisory, specifically the statement regarding common ownership. Id.
13. On Thursday, June 29, 2023, between approximately 10:00 a.m. and 12:00 p.m., Investigators Gardner and Terasconi conducted surveillance outside of Liquor N More at 35 Home Depot Drive, Plymouth, Massachusetts. Id.
14. At approximately 11:50 a.m., Investigators observed a white GMC truck pull up to the back door of the licensed premises. Investigators observed two individuals offloading alcoholic beverages from the vehicle into the licensed premises. Id.
15. Investigators approached the individuals, identified themselves, and asked where the product had come from. The driver was identified as Barry, and the other individual was

Marty. Marty would not answer questions and directed Investigators to speak to the owner. Marty then called Mr. Patterson. Id.

16. Investigators spoke to Mr. Patterson via telephone and asked him where the alcoholic beverages being delivered to Liquor N More in Plymouth had come from. Mr. Patterson stated the alcohol had come from Liquor 'N More in Dennis. Id.
17. Investigators asked Marty to produce the internal document labeled "Unposted Transfer Outs" for the alcoholic beverages being delivered from the Dennis store to the Plymouth location. Marty stated that he did not have this document. Investigators then asked Mr. Patterson for this document which he provided to Investigators via email. (Exhibits 12, 14)
18. Investigators asked Barry for a copy of the transportation permit which Barry provided. (Exhibits 7, 14)
19. Investigators inspected the storage room of the Liquor N More Plymouth location and observed boxes of alcoholic beverages stacked in groups with documents attached, labeled "Unposted Transfer Outs." Investigators also observed cases of alcoholic beverages which had labels or other markings on them which indicated that the cases had been transferred to and/or from other locations owned by Patriot Spirits, Inc. (Exhibit 14)
20. Patriot Spirits, Inc. has held a license under M.G.L. c. 138, § 15 in Plymouth since 2016 with no prior violations and in Dennis since 2011 with no prior violations.

#### DISCUSSION

Licenses to sell alcoholic beverages are a special privilege subject to public regulation and control, Connolly v. Alcoholic Beverages Control Comm'n, 334 Mass. 613, 619 (1956), for which States have especially wide latitude pursuant to the Twenty-First Amendment to the United States Constitution. Opinion of the Justices, 368 Mass. 857, 861 (1975). The procedure for the issuance of licenses and required conduct of licensees who sell alcoholic beverages is set out in Massachusetts General Laws, Chapter 138.

Chapter 138 gives the Commission the authority to grant, revoke and suspend licenses. Chapter 138 was "enacted ... to serve the public need and ... to protect the common good." M.G.L. c. 138, § 23. "[T]he purpose of discipline is not retribution, but the protection of the public." Arthurs v. Bd. of Registration in Medicine, 383 Mass. 299, 317 (1981). The Commission is given "comprehensive powers of supervision over licensees." Connolly, 334 Mass. at 617.

Every violation the Commission finds must be based on substantial evidence. See Embers of Salisbury, Inc. v. Alcoholic Beverages Control Comm'n, 401 Mass. 526, 528 (1988). "Substantial evidence" is "such evidence as a reasonable mind might accept as adequate to support a conclusion." Id. Evidence from which a rational mind might draw the desired inference is not enough. See Blue Cross and Blue Shield of Mass., Inc. v. Comm'r of Ins., 420 Mass. 707, 710 (1995). Disbelief of any particular evidence does not constitute substantial evidence to the contrary. New Boston Garden Corp. v. Bd. of Assessor of Boston, 383 Mass. 456, 467 (1981).

Here, Patriot Spirits, Inc. holds licenses under § 15 which were issued by the local licensing authorities of multiple municipalities, two of them being Plymouth, License No. 88935-PK-0984, and Dennis, License No. 00012-PK-0278.

According to § 15 of Chapter 138, “[t]he local licensing authorities in any city or town which votes to authorize the granting of licenses for the sale of all alcoholic beverages, and such authorities in any city or town which votes to authorize the granting of licenses for the sale of wines and malt beverages only, may grant licenses for the sale at retail of such alcoholic beverages or wines and malt beverages, as the case may be, not to be drunk on the premises...No such license shall be granted except to an applicant approved by the commission.” M.G.L. c. 138, § 15

When applying for licenses in Plymouth and in South Dennis, § 15A required that Patriot Spirits, Inc. provide a “...description of the location and area where the license is intended to be exercised, designating if practicable, the street and number. ...[w]here there are no premises actually in existence at the time the application is made, the applicant may file with the local licensing authorities a plan showing the actual dimensions of premises which are to be constructed on which the license is to be exercised.” M.G.L. c. 138, § 15A

§ 15 mandates, “[e]ach license shall describe the premises to which it applies. Not more than one location shall be included in any such license...” M.G.L. c. 138, § 15.

In addition, § 15 limits the number of licenses which may be held under the section and states that “[n]o person, firm, corporation, association or other combination of persons, directly or indirectly, or through any agent, employee, stockholder, officer or other person or any subsidiary whatsoever, shall be granted, in the aggregate, more than 9 such licenses in the commonwealth, or participate in decisions regarding the purchasing of alcoholic beverages or the purchasing of insurance or accounting or bookkeeping services, or receive any percentage or fee derived from gross revenues in exchange for management assistance, or participate in any other action designed to effect common results of more than 9 *licensees* under this section, or be granted more than one such license in a town or two in a city.” M.G.L. c. 138, § 15. (emphasis added) This language in M.G.L. c. 138, § 15 clearly establishes that Patriot Spirits, Inc. is a licensee at each location approved by the Commission and issued by the Local Licensing Authority.

Liquor ‘N More in Plymouth is charged with a violation of M.G.L. Ch. 138, § 23 Unlawful Purchase: No license issued under §§ 12, 14, or 15, and no certificate of fitness issued under § 30 shall authorize the sale of any alcoholic beverages other than those purchased from a licensee under §§ 18, 19, or 19F or 19C or from a holder of a special permit to sell issued under § 22A, and 204 CMR 2.05(3) The Person in charge of any vehicle used for the delivery of alcoholic beverages or alcohol shall carry an invoice for sales slip, stating the names and addresses of the purchaser and seller, the date and the amount of the purchase, and also itemizing the number of various kinds of containers and the kinds, quantities and brands of alcoholic beverages or alcohol.

Liquor ‘N More in Dennis is charged with a violation of M.G.L. c. 138, § 18 – Acting as a § 18 wholesale licensee without being properly licensed.

The Licensees are alleged to have been engaging in what the Commission refers to as consolidated buying.

Consolidated buying (also known as a cross-accumulation relationship, purchasing co-operative, group purchasing, and collective buying) is where two or more § 15 licensees combine their individual orders and place a single order with a § 18 wholesaler or farmer-series licensee so that the licensees can benefit from volume discount pricing that they otherwise would not be able to take advantage of if their orders were placed separately.

When two or more § 15 licensees engage in consolidated buying, the § 15 licensee placing the order on behalf of itself and other § 15 licensees is effectively acting as a wholesaler, which is unlawful under M.G.L. c. 138, § 18. The other § 15 licensees providing their orders to the § 15 licensee placing the consolidated order are then purchasing alcohol from an unauthorized source with the intent of selling that alcohol to the public, in violation of M.G.L. c. 138, § 23. (Exhibit 2)

The Licensees admitted to engaging in consolidated buying and stipulated to the facts alleged by the Investigative and Enforcement Division (Exhibit 14) yet assert said practices are lawful.

Patriot Spirits argues there is only one licensee charged, Patriot Spirits, Inc., and that consolidated buying requires two or more licensees participate. The Commission disagrees with this assertion and contends that two licensees did, in fact, participate here.

Patriot Spirits acknowledges the delivery of alcoholic beverages from Liquor 'N More in Dennis to Liquor 'N More in Plymouth but argues there was no sale, and thus no purchase from an unauthorized source. However, M.G.L. c. 138, § 41 states the delivery of alcoholic beverages is prima facie evidence of a sale. "The delivery of alcoholic beverages in or from a building, booth, stand or other place, except a private dwelling house, or in or from a private dwelling house if any part thereof or its dependencies is used as an inn, eating house or shop of any kind, or other place of common resort, such delivery in either case being to a person not a resident therein, shall be prima facie evidence that such delivery is a sale." M.G.L. c. 138, § 41.

Patriot Spirits' § 15 licenses authorize the establishments in Plymouth and Dennis to sell alcoholic beverages at retail to members of the public. M.G.L. c. 138, § 15.

While Chapter 138 allows § 15 license holders to deliver alcoholic beverages through the use of a state issued § 22 Transportation Permit, the fact remains that § 15 licensees are only authorized to sell to members of the public. In this matter, one § 15 retail package store delivered alcoholic beverages to another § 15 retail package store which is prima facie evidence that a sale occurred pursuant to M.G.L. c. 138, § 41.

According to § 30H of Chapter 138, "[p]ossession on the licensed premises by any licensee under this chapter of any alcoholic beverages or alcohol not authorized to be sold or used under the terms of his license shall be prima facie evidence that such beverage or alcohol is kept for sale in violation of this chapter." M.G.L. c. 138, § 30H.

Patriot Spirits mistakenly defends their position by pointing to the Massachusetts Appeals Court's ruling in Whitehall Co. v. Alcoholic Beverages Control Commission, 7 Mass. App. Ct. 538 (1979). In Whitehall Co. v. Alcoholic Beverages Control Commission, the Court ruled that Whitehall Co. which held three M.G.L. c. 138, § 18 wholesaler licenses was "considered the licensee for purposes

of both § 18 and § 25A.” *Id.* at 541. The Appeals Court further held that “one licensee under § 18 can hold several licenses for different premises.” *Id.*

Patriot Spirits, Inc. is unlike Whitehall Co. because it is issued M.G.L. c. 138, § 15 package store licenses and not a M.G.L. c. 138, § 18 wholesaler license. M.G.L. c. 138, § 18 wholesaler licenses are issued by the Commission contrary to M.G.L. c. 138, § 15 package store licenses that are issued by local licensing authorities after Commission approval. M.G.L. c. 138, § 18 wholesaler licenses are state issued licenses authorizing the licensee to conduct business throughout the Commonwealth, while Patriot Spirits, Inc. is a licensee in Plymouth and a licensee in Dennis but not in municipalities where it does not hold a M.G.L. c. 138, § 15 license. The word “licensee” in M.G.L. c. 138, § 15 and M.G.L. c. 138, § 18 does not concern the same subject matter and does not have the same meaning.

M.G.L. c. 138, § 2 states that “[n]o person shall manufacture, with intent to sell, sell or expose for sale, store, transport, import or export alcoholic beverages or alcohol, except as authorized by this chapter.” M.G.L. c. 138, § 2. § 2 was interpreted by the Massachusetts Supreme Judicial Court in the matter of CellarMaster Wines of Massachusetts, Inc. v. Alcoholic Beverages Control Comm’n, which concluded that the “[r]egulation of the liquor industry in Massachusetts is comprehensive and pervasive. See G.L. c. 138. “The powers of the States in dealing with the regulation of the sale of intoxicating liquors are very broad. What they may wholly prohibit, they may permit only on terms and conditions prescribed by the Legislature.” Connolly v. Alcoholic Beverages Control Comm’n, 334 Mass. 613, 619 (1956).” CellarMaster Wines of Massachusetts, Inc. v. Alcoholic Beverages Control Commission, 27 Mass. App. Ct. 25, 27 (1989) The Court noted there is a “sweep to GL c 138 § 2 which prohibits a variety of activities involving alcoholic beverages, ... “except as authorized by this chapter.”” CellarMaster at 28.

According to the Court in CellarMaster, a holder of a § 15 package store retail license can lawfully conduct business only in the manner authorized by G.L. c. 138, § 15. CellarMaster at 27-28.

The evidence shows and the Licensees admitted that Liquor ‘N More in Plymouth and Liquor ‘N More in Dennis, two package stores licensed by two different local licensing authorities, consolidated their orders placed with a Massachusetts wholesaler. The alcoholic beverages were delivered by the wholesaler to Liquor ‘N More in Dennis which then delivered a portion of the alcoholic beverages to Liquor ‘N More in Plymouth. (Exhibit 14) Such activity is not authorized under M.G.L. c. 138.

Regarding the charge of a violation of M.G.L. c. 138, § 18, Patriot Spirits stipulated to the fact that the people in charge of the vehicle used for transporting the alcoholic beverages were not in possession of the required documentation. *Id.*

The Commission is persuaded Liquor ‘N More in Plymouth violated M.G.L. c. 138, § 23 and 2.04 CMR 2.05(3), and Liquor ‘N More in Dennis violated M.G.L. c. 138, § 18.

CONCLUSION

Based on the evidence, the Commission finds Patriot Spirits Inc., d/b/a Liquor 'N More in Plymouth, License # 88935-PK-0984, violated:


- 1) M.G.L. Ch. 138, § 23 Unlawful Purchase: No license issued under §§ 12, 14, or 15, and no certificate of fitness issued under § 30 shall authorize the sale of any alcoholic beverages other than those purchased from a licensee under §§ 18, 19, or 19F or 19C or from a holder of a special permit to sell issued under § 22A, which occurred from April 24, 2023, to June 29, 2023; and
- 2) 204 CMR 2.05 (3) The person in charge of any vehicle used for the delivery of alcoholic beverages or alcohol shall carry an invoice or sales slip, stating the names and addresses of the purchaser and seller, the date and the amount of the purchase, and also itemizing the number of the various kinds of containers and the kinds, quantities, and brands of alcoholic beverages or alcohol, which occurred from April 24, 2023, to June 29, 2023.

As a result, the Commission **SUSPENDS the license of Liquor 'N More in Plymouth, License # 88935-PK-0984 for a period of twenty (20) days of which five (5) days will be served and 15 days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations are found by this Commission.**


Based on the evidence, the Commission finds Patriot Spirits Inc., d/b/a Liquor 'N More in Dennis, License # 00012-PK-0278, violated M.G.L. c 138, § 18 – Acting as a § 18 wholesale licensee without being properly licensed. As a result, the Commission **SUSPENDS the license of Liquor 'N More in Dennis, License # 00012-PK-0278, for a period of twenty (20) days of which five (5) days will be served and 15 days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations are found by this Commission.**
